MBE / WBE: This contract will be awarded in compliance with Chapter 2-9 of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.

This contract is for the purchase, installation, and testing of a Forced Draft (FD) Fan motor at the Decker Creek Power Station. Two FD Fans are needed to supply combustion air to the boiler. This motor will replace the existing motor which is original equipment installed in 1972. The fan motor has failed four times in the last 15 years. The FD Fan is vital to the operation of the unit as it contributes half of the unit load. It could cause a considerable amount of revenue loss to Austin Energy if it is not operating to full capacity. The new motor will improve the reliability of operation.
