MBE / WBE: This contract will be awarded in compliance with Chapter 2-9 of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.

Currently, the City has a contract for the lease of golf course maintenance equipment, which expires in December. Because there has been a major reduction in force, less equipment is required for maintenance purposes. Staff determined it was in the City's best interest to pursue purchasing equipment rather than exercise the option to continue leasing. The current lease is \$303,000 per year compared to this purchase of approximately \$200,000 per year for the next four years.

This contract is for the purchase of golf course maintenance equipment. It will be used by staff for five municipal golf courses for the daily maintenance of turf area. Having this equipment allows for more versatility with limited staff and sharing of equipment among the City's five golf course facilities. This equipment will be used to perform course and grounds maintenance including all mowing tasks, aerifing, spreading and spraying fertilizers for all areas of the golf courses.

Seven types of mowers, ranging from greens mowers to lightweight reel mowers, will be used to prepare the greens, tees, fairways and rough (taller grass outside the fairways) for daily golf play. Blowers will be used to clear leaves and clippings off of golf course turf areas. An aerifier will be shared by all the golf courses and used to relieve soil compaction to increase water and air movement into the soil. Topdressers and fertilizer spreaders will be used to add soil and nutrients to the playing surfaces. Attachments such as grooming reels, trap rakes, leaf rakes and blades will be used to maintain the various playing surfaces.

This equipment will be serviced under warranty for a three-year term and all parts and labor will be included. This agreement also guarantees the labor rate for non-warranty service. City staff will perform
