

This project consists of providing sidewalk and Americans with Disabilities (ADA) approved curb ramp improvements along Northland Drive from Burnet Road to Shoal Creek Boulevard, and along Allandale from Shoal Creek Boulevard to Mopac. This advance funding agreement between the City of Austin and TxDOT is required because the project site is within TxDOT right-of-way and therefore requires a TxDOT permit. The advance funding agreement states that the City will pay TxDOT \$8,987 for their administrative costs, which includes their costs to review and approve the construction plans. Under the terms of this advance funding agreement, the City will administer the design, bid letting and construction phases of the project. The estimated construction cost is \$665,531. The City shall fund 100% of the costs required to complete the project. TxDOT is providing no funds for the project. Upon execution of this agreement, the city is required to send TxDOT \$8,987 for TxDOT's administrative costs.
