<u>SUBJECT:</u> Approve an ordinance amending Section 12-4-24 of the City Code to add a portion of Rivercrest Drive to the list of streets having a maximum speed limit of 25 miles per hour; and amending Section 12-4-63 of the City Code to relocate the Crockett High School speed zone on a portion of Stassney Lane.

AMOUNT & SOURCE OF FUNDING: Funding in the amount of \$300 is available in the Fiscal Year 2004-2005 Operating Budget of the Public Works Department for the installation of necessary speed limit signs.

FISCAL NOTE: There is no unanticipated fiscal impact. A fiscal note is not required.

In order to modify or alter the existing speed limit of a street, the Texas Traffic Laws require that a traffic engineering investigation be performed. An investigation of Rivercrest Drive was conducted by the Transportation Division of the Public Works Department in accordance with the procedures specified in the Texas Procedures for Establishing Speed Zones, 1997. The Transportation Division recommends the following.

Amendment to Section 12-4-24 (Maximum Speed of 25 Miles Per Hour):

Add: Rivercrest Drive from 600 feet north of Hillbilly Lane to 150 feet south of Troll Haven.

In 1997 changes were made to the Crockett High School Zone on Stassney Lane (west), but the ordinance was not changed to reflect these modifications, and no record of the associated study could be found. The Transportation Division of the Public Works Department has completed another investigation of this zone so that changes could be made if appropriate, and the ordinance could be modified in accordance with recommendations. Traffic volumes, traffic speeds, and pedestrian volumes and patterns were evaluated in order to determine what, if any, modifications could be made to improve the safety of the students attending Crockett High School. As a result of these investigations, the Transportation Division recommends revision of the ordinance to reflect the existing field conditions. No funding is needed as existing speed limit signs are in place.





ORDINANCE NO.

AN ORDINANCE AMENDING SECTION 12-4-24 OF THE CITY CODE TO ADD A PORTION OF RIVERCREST DRIVE TO THE LIST OF STREETS HAVING A MAXIMUM SPEED LIMIT OF 25 MILES PER HOUR; AND AMENDING SECTION 12-4-63 OF THE CITY CODE TO RELOCATE THE CROCKETT HIGH SCHOOL SPEED ZONE ON STASSNEY LANE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. Section 12-4-24 (Maximum Speed Limit of 25 Miles Per Hour) of the City Code is amended to add:

Rivercrest Drive from 600 feet north of Hillbilly Lane to 150 feet south of Troll Haven.

PART 2. Section 12-4-63 (20 Mile Per Hour School Zones) of the City Code is amended as follows:

Stassney Lane (West) from 106 [330] feet east of Kings Highway to 300 [150] feet west of Manchaca Road (Crockett High School).

PART 3. The amendments made in this ordinance shall be incorporated in alphabetical order and the existing subsections renumbered accordingly.
