**SUBJECT:** Approve a resolution authorizing the filing of eminent domain proceedings for the ABIA Noise Mitigation Project to acquire fee simple title to a tract of land containing 33.893 acres out of the Noel M. Bain Survey No. 1, Abstract No. 61, Travis County, TX, in the amount of \$325,000. The owner of the property interests sought to be acquired is W.A. DENTON also known as WILLIAM ALVIN DENTON. The Property is located at 11506 McAngus Road, Del Valle, TX.

## BOARD AND COMMISSION ACTION: N/A

The property and residence located at 11506 McAngus Road, Del Valle, TX, is a part of the approved ABIA Noise Mitigation Project. The purpose of the project is to reduce noise impacts and ensure land use compatibility within the airport vicinity.

The land to be acquired is approximately 33.893 acres. The improvements include a: 1,673 square foot manufactured home (believed to have been constructed in 1985); 2,450 square foot metal workshop; 3,000 square foot barn; 2,173 square foot horse stable; riding arena; 160 square foot storage container; 7,700 linear feet of fencing; and three stock ponds. The fair market value of the property including improvements is \$325,000, as determined by an independent appraiser.

The City of Austin has attempted to purchase the property from the landowner, but the parties have been unable to agree on an appropriate price.

The City of Austin Law Department is requesting authorization to file a suit in eminent domain on behalf of the City of Austin and the Federal Aviation Administration.


