SUBJECT: Authorize execution of a 12-month supply agreement with MWI VETERINARY SUPPLY, Meridian, ID, for veterinary supplies and equipment in an amount not to exceed \$200,000, with three 12month extension options in an amount not to exceed \$200,000, for a total agreement amount not to exceed \$800,000.

AMOUNT & SOURCE OF FUNDING: Funding in the amount of \$166,666 is available in the Fiscal Year 2004-2005 Approved Operating Budget of the Health and Human Services Department. Funding for the remaining two months of the original contract period and extension options is contingent upon available funding in future budgets.

FISCAL NOTE: There is no unanticipated fiscal impact. A fiscal note is not required.
