The design plans for the FM 969 and Decker to 183 Project require the acquisition of a permanent waterline easement on land located at 7700 East Martin Luther King Jr. Boulevard, Austin, TX.

The City of Austin is relocating the utilities located in the Right-of-Way of FM Road 969 pursuant to a request from the Texas Department of Transportation in order to construct a raised median with left-turn lanes to improve traffic flow and enhance safety.

The City of Austin has attempted to purchase the permanent waterline easement from the landowner. However, the parties have been unable to agree on an appropriate price. The Law Department is requesting authorization to file a lawsuit in eminent domain on behalf of the City of Austin.
