SUBJECT: Approve a resolution authorizing the filing of eminent domain proceedings for the FM 969 and Decker to 183 Project to acquire a 2,257 square foot permanent waterline easement located in the James Burleson Survey No. 19, Abstract No. 4, Travis County, TX, (Lot 2, Gerald Addition) in the amount of \$2,820. The owner of the property interest sought to be acquired is GRIESBACH PROPERTIES, INC., Austin, TX. The property is located at 7900 FM Road 969, Austin, TX.

The design plans for the FM 969 and Decker to 183 Project require the acquisition of a permanent waterline easement on land located at 7900 FM Road 969, Austin, TX.

The City of Austin is relocating the utilities located in the Right-of-Way of FM Road 969 pursuant to a request from the Texas Department of Transportation in order to construct a raised median with left-turn lanes to improve traffic flow and enhance safety.

The City of Austin has attempted to purchase the permanent waterline easement from the landowner. However, the parties have been unable to agree on an appropriate price. The Law Department is requesting authorization to file a lawsuit in eminent domain on behalf of the City of Austin.

WHEREAS, the Council finds that acquisition of the property interest described in the attachment is necessary for a public use; and

WHEREAS, the City has been unable to agree with the owner on the fair market value of the property interest to be acquired; **NOW, THEREFORE**,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

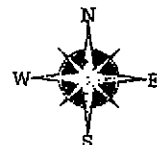
The City Attorney is authorized to file a suit in eminent domain and take other action deemed appropriate to economically effect the needed acquisition of the property interest.

The owner of the property interest to be acquired is Griesbach Properties, Inc., and the property is located at 7900 FM Road 969, Austin, Travis County, Texas.

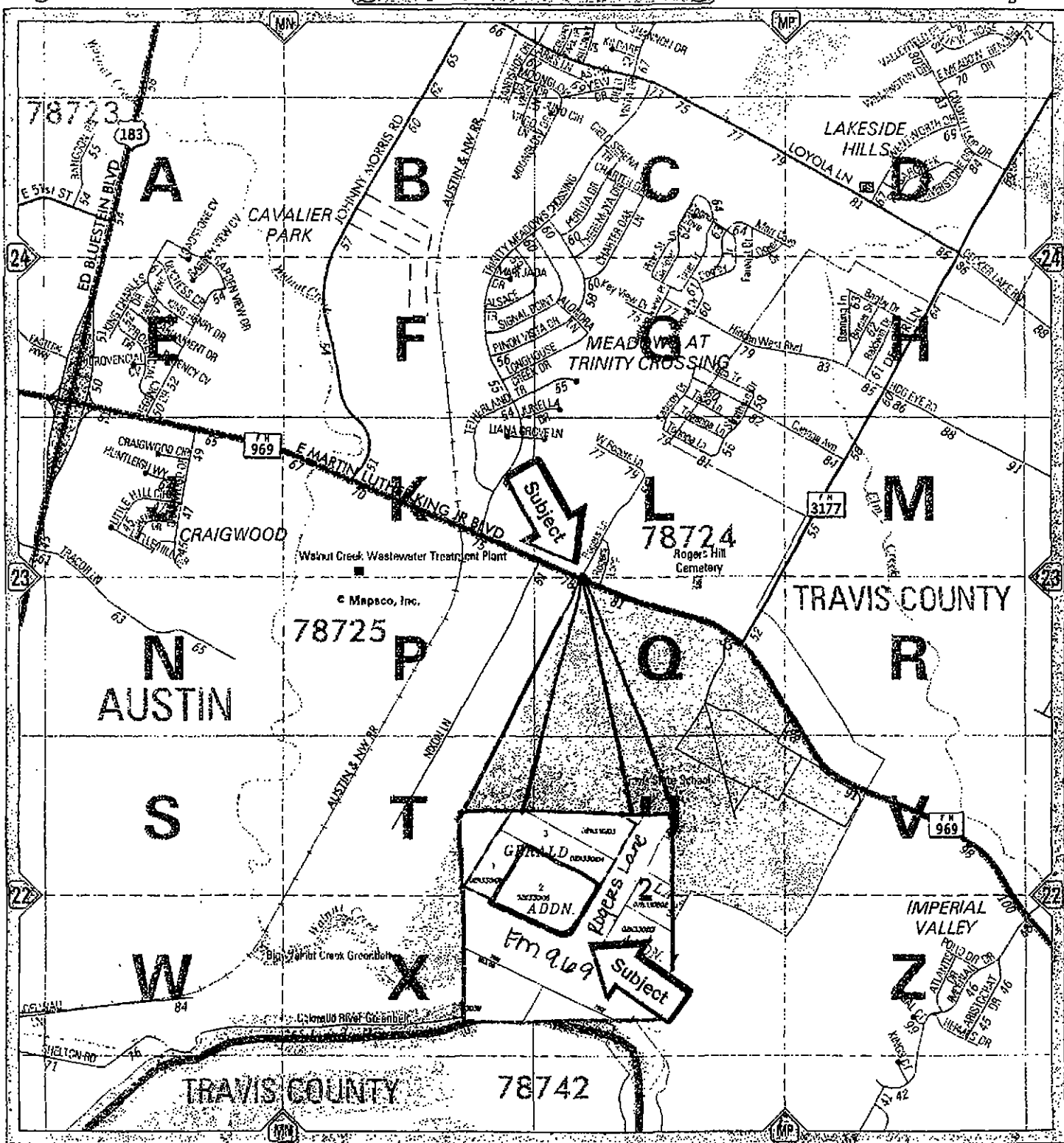
