<u>SUBJECT</u>: Authorize negotiation and execution of an Interlocal Agreement with the Texas Department of Transportation (TxDOT) for construction of traffic signal improvements as the FM 734: Neenah Ave to Amherst Dr. Signals Improvement Project to be funded with Transportation Equity Act for the 21st Century (TEA-21) funds and 20% matching City of Austin (City) funds from the Capital Metropolitan Transportation Authority (CMTA) Quarter Cent.

AMOUNT & SOURCE OF FUNDING: Total project cost is \$236,693. 80% of project costs will be provided from TxDOT grant funds. Funding for the remaining 20% is available in Fiscal Year 2004-2005 Amended Capital Budget of the Public Works Department.

PRIOR COUNCIL ACTION: On August 7, 2003 the Council approved a resolution authorizing the City Manager to submit roadway, bicycle and pedestrian-related projects for consideration by Capital Area Metropolitan Planning Organization (CAMPO) for Federal funding under the Federal Surface Transportation Program Metropolitan Mobility (STP MM) fund. That resolution included \$236,693 (\$189,354 in Federal grant funds and the City's 20% match of \$47,339) for the FM 734: Neenah Ave to Amherst Dr. Signals Improvement Project.

The FM 734: Neenah Ave to Amherst Dr. Signals Improvement Project is part of the Transportation Engineering Division, Traffic Signal Section program to provide safe and efficient multi-modal transportation. The Project involves installation of aerial and underground cable and control equipment to establish synchronization, facilitate communication and give remote control of traffic signals along the arterial to the City's Traffic Management Center. The Project will aid the City in its goals to reduce air pollution and traffic congestion by improving traffic signal infrastructure and maximizing synchronization.
