**SUBJECT:** Authorize execution of a 12-month supply agreement with COVERT CHEVROLET OLDSMOBILE, Bastrop, TX, for the purchase of captive repair parts for General Motors light duty vehicles in an amount not to exceed \$150,000, with three 12-month extension options in an amount not to exceed \$150,000 per extension option, for a total agreement amount not to exceed \$600,000.

<u>AMOUNT & SOURCE OF FUNDING:</u> Funding in the amount of \$125,000 is available in the Fiscal Year 2004-2005 Approved Operating Budget of the Financial and Administrative Services Department, Fleet Fund. Funding for the remaining two months of the original contract period and extension options is contingent upon available funding in future budgets.

FISCAL NOTE: There is no unanticipated fiscal impact. A fiscal note is not required.
