**SUBJECT:** Authorize execution of a 12-month service agreement with MAJESTIKLEEN, INC., Austin, TX, for janitorial services at the north branch libraries in an amount not to exceed \$58,230, with two 12-month extension options in an amount not to exceed \$58,230 per extension option, for a total agreement amount not to exceed \$174,690.

AMOUNT & SOURCE OF FUNDING: Funding in the amount of \$38,820 is available in the Fiscal Year 2004-2005 Approved Operating Budget of the Library Department. Funding for the remaining four months of the original contract period and extension options is contingent upon available funding in future budgets.

This contract will provide for janitorial services at the nine north branch libraries - Howson, North Village, Old Quarry, Yarborough, University Hills, Windsor Park, Little Walnut, Milwood and Spicewood Springs. Janitorial services will be performed five days per week at each branch. Services include the cleaning of all floors, windows, furniture and fixtures, shelving, and restrooms and employee lounges, as well as the removal of trash. The libraries total 75,696 square feet.
