The Texas Department of Transportation (TxDOT) has entered into a Developer Agreement with Lone Star Infrastructure, JV (LSI) to construct the Central Texas Turnpike Project identified as State Highway 130 (SH-130). SH-130 is a toll road that extends 91 miles southward from the IH-35 — SH-195 intersection north of Georgetown to IH-10 near Seguin. LSI will be constructing the toll road, including utility relocations along the route of SH-130. LSI will pay for the design, construction, and City of Austin inspection of any adjustments of existing City utilities necessary to construct the toll road along the SH-130 route. The design and construction of these adjustments will follow Austin Water Utility Standards.

LSI has identified six areas where adjustments to existing water and wastewater lines will be required. Austin Water Utility (AWU) has determine there is a need to upgrade the existing utilities or place new encasements for future lines in or across the SH-130 Rights-of-Way. This authorization will allow LSI to design and construct the betterments identified by AWU as necessary in the areas where existing utilities are being relocated. The cost associated with these betterments will not exceed \$300,000.
