MBE / WBE: This contract will be awarded in compliance with Chapter 2-9 of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.

This contract will provide business consulting services to design and implement a research study of the electric territories open to competition within ERCOT. Due to the competitive nature of the open markets, it has become increasingly difficult for Austin Energy to collect information regarding commercial and industrial electric energy and delivery prices within the State of Texas for comparative purposes.

This energy consulting service will conduct research into and report on the commercial and industrial electric markets within the open areas of ERCOT. Austin Energy (AE) will receive the collection of price and service data from the small commercial, medium commercial and industrial, and large commercial and industrial customer segments that purchase their electric service in the open markets of Texas. Using the collected data, AE will receive a comparison of the bundled prices in these markets to AE's bundled rates within each segment. The data collection requirements are: price of electric energy, price of electric energy delivery, terms & conditions, bill components, information and payment options and value added services.

The energy consulting firm will deliver a comprehensive written report and presentations of their findings.
