**MBE / WBE:** This contract will be awarded in compliance with Chapter 2-9 of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.

This contract is for the purchase of one electric powered boom lift manufactured by JLG Industries, Inc. It will be assigned to the Parks and Recreation Department (PARD) to support the Operations Unit, which is responsible for grounds and facilities maintenance. This boom lift will be used to perform preventative maintenance and repairs to facilities and equipment not safely accessible by ladder.

This is a new piece of equipment necessary to support maintenance staff in various applications. The boom lift will be especially useful with painting, window washing, and rain gutter maintenance, at various PARD facilities and City museums. It will be used to maintain scoreboards and to replace lights at indoor recreation centers and outdoor recreational fields used for tennis, baseball, softball, basketball, and soccer. It will assist with stringing lights and hanging other decorations for the Trail of Lights Festival in December of each year.
