<u>SUBJECT:</u> Authorize execution of a 12-month supply agreement with HERSEY-METERS COMPANY, Cleveland, NC, for the purchase of water meters in an amount not to exceed \$56,022.80, with two 12-month extension options in an amount not to exceed \$56,022.80 per extension option, for a total contract amount not to exceed \$168,068.40.

AMOUNT & SOURCE OF FUNDING: Funding in the amount of \$4,668.56 is available in the Fiscal Year 2004-2005 Approved Operating Budget of the Austin Water Utility. Funding for the remaining 11 months of the original contract period and extension options is contingent upon available funding in future budgets.

FISCAL NOTE: There is no unanticipated fiscal impact. A fiscal note is not required.

MBE / WBE: This contract will be awarded in compliance with Chapter 2-9 of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.

This contract is for the purchase of Horizon Cold Water Meters that are carried in inventory at the Austin Water Utility's Webberville and South Industrial warehouses. They are used in the Hersey Fire Line Demand Meters as bypasses to register and determine water consumption for fire fighting demand.

The Horizon Cold Water Meter is manufactured by Hersey-Meters Company. It is the only approved meter that can be installed on the Hersey Fire Line Demand Meter. The Hersey Fire Line Meter operates as a complete assembly and the use of any other meter would void the warranties of the system.
