<u>SUBJECT</u>: Authorize execution of two 12-month supply agreements with RTI HOT MIX, Pflugerville, TX and CAPITOL AGGREGATES LTD, Austin, TX for the purchase of hot mix-cold laid asphaltic concrete (cold mix) in amounts not to exceed \$187,200 and \$152,000 respectively, with two 12-month extension options in amounts not to exceed \$187,200 and \$152,000 respectively per extension option, for total agreement amounts not to exceed \$561,600 and \$456,000 respectively.

AMOUNT & SOURCE OF FUNDING: Funding in the amount of \$28,267 is available in the Fiscal Year 2004-2005 Approved Operating Budget of the Austin Water Utility. Funding for the remaining 11 months of the original contract period and extension options is contingent upon available funding in future budgets.

FISCAL NOTE: There is no unanticipated fiscal impact. A fiscal note is not required.

## **PRICE ANALYSIS**

- a. Adequate competition.

- c. The pricing offered represents a 25% increase in delivery to the Zones and 17% increase for Pickup from the last contract awarded July 2004. This increase can be attributed to the rising fuel and production cost.
