<u>SUBJECT:</u> Authorize execution of a construction contract with CAPITAL EXCAVATION COMPANY, Austin, TX, for the Riverside Drive and Barton Springs Road Street Reconstruction and Utility Adjustment Project from South Congress Avenue to South First Street and Town Lake Park/Riverside Drive Reconstruction from South First Street to South Lamar Boulevard in the amount of \$6,983,031.67 plus a \$698,303.17 contingency, for a total contract amount not to exceed \$7,681,334.84.

<u>AMOUNT & SOURCE OF FUNDING</u>: Funding in the amount of \$5,176,643.09 is available in the Fiscal Year 2004-2005 Approved Capital Budget of the Public Works Department and funding in the amount of \$2,504,691.75 is available in the Fiscal Year 2004-2005 Capital Budget of the Austin Water Utility.

**PRIOR COUNCIL ACTION:** Resolution 021205-66C was approved on December 5, 2002 to include the following on Council Member Slusher's motion, Mayor Pro Tem Goodman's second on a 6-0 vote. Council Member Wynn voted nay.

Group A

\* Reduce width of Riverside Drive to one lane in each direction in the vicinity of Town Lake Park.

Group B

\* Continue to develop alternatives that would make viable the removal of Riverside Drive as an at-grade roadway through Town Lake Park. (Riverside Drive shall not be permanently closed through the Park until such time as alternatives are implemented to replace the Riverside Drive's lost traffic capacity.) There was a friendly amendment from Council Member Alvarez to change the word "replace" with "mitigate" in the last sentence. This was accepted by the maker of the motion and Mayor Pro Tem Goodman, who seconded the motion.

August 4, 2005, Item 27 Approved a resolution directing the City Manager to present a briefing to Council regarding the current cost estimate for the construction of Town Lake Park and the impact of reducing Riverside Drive where it passes through the park to two lanes, giving particular attention to the addition of density in the downtown area, the conversion of Cesar Chavez to two-way and future traffic flow on Barton Springs Road, Lamar Boulevard, and South First Street. (Council Member Jennifer Kim and Mayor Will Wynn).

## 1) Reconstruction Segment from South 1<sup>st</sup> Street to South Congress Avenue:

The project limits are on Riverside Drive from South Congress Avenue to South Lamar Boulevard and Barton Springs Road from South Congress Avenue to South First Street. The work will consist of the replacement of storm sewer, water and wastewater prior to full depth street reconstruction on Riverside Drive and Barton Springs Road from South Congress Avenue to South First Street. Concrete intersections will be constructed on Riverside Drive at Barton Springs Road and South Congress Avenue.

## 2) Riverside Drive reduction segment:

Roadway realignment with roundabout and reduction of lanes from four lanes to two lanes with an additional 26 parking spaces will be constructed on Riverside Drive between South First Street and South Lamar Boulevard.

Work is estimated to begin in October 2005 with an estimated completion date of May 2006. One merchant meeting has been held with another scheduled prior to construction. Status updates have been provided via email as milestones have been reached during the design, bid and contract award phase. All neighborhood associations have been notified of the project.

Due to the potential for unknown subsurface conditions and utility conflicts when working in the right-ofway, a 10% contingency in funding has been included to allow for the expeditious processing of any future change orders. The contract allows 210 calendar days for completion of this project. Bid documents were distributed to 7 general contractors. Bids were opened on July 21, 2005. Capital Excavation Company submitted the lower of 2 bids received:

The contractor's choice of work methodology provides for subcontracting opportunities in 13 areas, which are listed below. Project specific sub goals stated in the solicitation were 5.1% African American (MB); 11.95% Hispanic (MH); .24% Native American (MN); .52% Asian Americans (MA); 5.82% WBE.
