SUBJECT: Approve a resolution authorizing the filing of eminent domain proceedings for the Onion Creek/Lower South Boggy Phase II Project, a portion of the Austin Clean Water Program, to acquire a 1,461 square foot permanent access easement out of the Santiago Del Valle Grant, being a portion of Lot 1, Boggy Creek Addition Amended, City of Austin, Travis County in the amount of \$300. The owner of the needed property interest is RIDGWAY-HENDRICKSON, INC., dba RIDGWAY, INC., of Austin, Texas. The property is located at 8201 Bluff Springs Road, Austin, Travis County, Texas.

The design plans for the Onion Creek/Lower South Boggy Phase II Project, a portion of the Austin Clean Water program, require acquisition of a permanent access easement on the property located at 8201 Bluff Springs Road, Austin, Travis County, Texas.

The City of Austin has attempted to purchase the permanent access easement from the landowner and the parties have agreed on an appropriate price. The property title, however, is not curable through standard means; therefore, friendly condemnation is required. The Law Department is requesting authorization to file a lawsuit in eminent domain on behalf of the City of Austin.

# **RESOLUTION NO. 20050929-0**

WHEREAS, the City Council of the City of Austin has found that public necessity requires the City of Austin to acquire a certain real property interest for public purposes as set out below; and

WHEREAS, the City of Austin has attempted to purchase that real property interest but title to the needed real property interest is not curable through standard means; therefore condemnation is required; NOW, THEREFORE,

### BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

That the City Attorney, or other authorized designee, is hereby authorized and directed to file, or cause to be filed, a suit in eminent domain on behalf of the City of Austin against the owner now having, or who may acquire, an interest in the real property interest needed by the City, described and located below, for the public purposes set out below, and to take whatever other action may be deemed appropriate to economically effect the needed acquisition.


