This project will include reconstruction and drainage improvements on two downtown alleys. Minor water and wastewater casting adjustments to final pavement grade are included in the project as well. The alleys are located at 100 East 5th Street and 400 Lavaca Street.

The contract allows 80 calendar days for completion of this project.

Bid documents were distributed to three general contractors. Bids were opened on August 4, 2005. MAC, Inc. submitted the lower of two bids received:

MAC, Inc., Austin, Texas \$247,530.00 Muniz Concrete & Contracting, Inc., Austin, Texas \$249,591.70

The contractor's choice of work methodology provides for six areas of subcontracting opportunities: pipe culvert construction, erosion control, construction photography, traffic control, concrete supplier, grate inlets supplier.

Participation goals stated in the solicitation were 16.08% MBE and 7.02% WBE. Total participation estimated on base bid amount of \$247,530.00:


