The proposed expansion of the downtown contract service area includes seven additional blocks:

- the city blocks adjacent to West 5th Street between Guadalupe and Colorado Streets,
- the city block south of West 4th Street between Lavaca and Colorado Streets,
- the city block south of East 5th Street between San Jacinto Boulevard and Trinity Street, and
- the city block north of East 7th Street between Neches and Red River Streets.
