

ORDINANCE NO. 040913-05 - Corrected

AN ORDINANCE AUTHORIZING FEES, FINES, AND OTHER CHARGES TO BE CHARGED BY CITY DEPARTMENTS FOR FISCAL YEAR 2004-2005 BEGINNING ON OCTOBER 1, 2004, AND ENDING ON SEPTEMBER 30, 2005.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. The City Council authorizes the fees and fines listed in the attached Exhibit "A" to be charged by the various City departments for Fiscal Year 2004-2005 beginning on October 1, 2004, and ending on September 30, 2005.


PART 2. To the extent that a previous ordinance conflicts with this ordinance, the earlier ordinance is repealed.

PART 3. Except as otherwise specifically provided for an individual fee in Exhibit "A", this ordinance takes effect on October 1, 2004. A fee for which a specific effective date has been provided in Exhibit "A" takes effect on that specified effective date provided for that fee.

SUBJECT: Correction to Ordinance No. 040913-05

On September 13, 2004, the council adopted the 2004-2005 Fee Schedule attached as Exhibit A to Ordinance No. 040913-05. This ordinance authorizes the fees, fines, and other charges that the various City departments will charge in 2004-2005 Fiscal Year. When the council deliberated on this ordinance at the September 13 meeting, it voted to reduce the Aviation Department's off-airport parking facility permit fee from 10 percent of the facility operator's gross revenue, as presented in the proposed budget, to four percent of the operator's gross revenue.

The Fee Schedule exhibit that was attached to the executed Fee Schedule ordinance did not reflect this change to the Aviation Department's off-airport parking services fee and incorrectly includes language from the proposed budget indicating a fee based on 10 percent of the gross revenues of an off-airport parking facility.

Because this is a typographical staff error, a corrected ordinance has been prepared for execution. The original executed ordinance shall be marked "Superceded" and the replacement ordinance shall be marked "Corrected". Based on the length of this ordinance, if your office receives a request for Ordinance No. 040913-05, you may inquire if the requestor wishes to receive copies of both ordinances or only the "Corrected" ordinance. If you do not receive a response, copies of both ordinances should be delivered to the requestor.
