

**RESOLUTION NO. 20050407-064**

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

The City authorizes the use of approximately 1.265 acres of land for a wastewater line, 0.2551 acres of land for a lift station, and 2.3619 acres of land for temporary work space, described in Exhibit A, to construct, use, maintain, repair, and replace a wastewater line in a tunnel for construction of the Barton Creek Lift Station Relief Main – Section 2 through dedicated parkland known as Butler Shores Park in accordance with Sec. 26.001 et seq. of the Texas Parks and Wildlife Code.

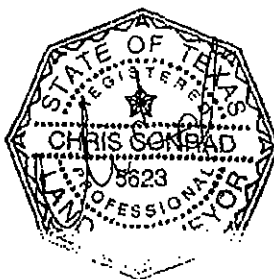
