ORDINANCE NO. 040415-02

AN ORDINANCE AMENDING ORDINANCE NO. 040311-05 CALLING THE MAY 15, 2004, SPECIAL MUNICIPAL ELECTION TO ADOPT CERTAIN CHANGES TO ELECTION DAY POLLING LOCATIONS, THE LIST OF ELECTION DAY PRECINCT JUDGES, AND EARLY POLLING LOCATIONS; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. Ordinance No. 040311-05 is amended to adopt changes to the election day polling locations, the list of election day precinct judges, and early voting locations only as to those items reflected in Exhibits A, B, and C of this ordinance.

PART 2. The Council finds that the need to adopt and publish polling locations and the list of election precinct judges constitutes an emergency. Because of this emergency, this ordinance takes effect immediately on its passage for the immediate preservation of the public peace, health, and safety.
