

RESOLUTION NO. 040729-109

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

WHEREAS, the City Council was requested to review and approve the use of dedicated parkland for a wastewater tunnel and temporary staging areas through parkland known as Zilker Park, Butler Shores, Pitch and Putt and Auditorium Shores; and

WHEREAS, notice of public meeting to be held on July 29, 2004 was given for three consecutive weeks on July 4, 11, and 18, 2004, in a newspaper of general circulation; and

WHEREAS, such public hearing was held July 29, 2004, by the City Council to determine the approval of the improvements proposing the use of parkland; **NOW, THEREFORE**,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

The City Council finds that, having taken into account clearly enunciated local preferences, there is no feasible and prudent alternative to the use of parkland (detailed in the attached Exhibit "A") for the proposed wastewater tunnel and temporary staging areas and such proposed uses are approved.

That the City Council finds that the program of improvements includes all reasonable planning to minimize harm to the parkland from the resulting use.

That the City Manager or his designee be authorized to take such measures as may be necessary, favorable or required to secure placement of the wastewater tunnel.
