

# AUSTIN CITY COUNCIL MINUTES

## REGULAR MEETING THURSDAY, MARCH 24, 2005

**Invocation:** Rev. Randy Phillips, Pastor, Promiseland West

The following represents the actions taken by the Austin City Council in the order they occurred during the meeting. While the minutes are not in sequential order, all agenda items were discussed. The City Council of Austin, Texas, convened in a regular meeting on Thursday, March 24, 2005 in the Council Chambers of City Hall, 301 W. 2<sup>nd</sup> Street, Austin, Texas.

Mayor Wynn called the Council Meeting to order at 10:14 a.m.

#### **CONSENT AGENDA**

The following items were acted on by one motion. No separate discussion or action occurred on any of the items. The consent items were approved on Council Member Alvarez' motion, Mayor Wynn's second on a 7-0 vote.

- 1. Approval of minutes from the meeting of March 10, 2005.

  The minutes from the meeting of March 10, 2005 were approved.
- 2. Approve issuance of a rebate in the amount of \$72,141 to ST. EDWARDS UNIVERSITY for the installation of a high efficiency chiller and variable frequency drives at 3001 S. Congress Avenue. (Funding in the amount of \$72,141 is available in the Fiscal Year 2004-2005 Operating Budget of the Conservation Rebates and Incentive Budget of Austin Energy.) (Recommended by the Electric Utility Commission and the Resource Management Commission.)

The motion authorizing the issuance of a rebate in the amount of \$72,141 was approved.

3. Authorize negotiation and execution of a cost participation agreement with Rancho Alto Ventures, Ltd., a Texas limited partnership providing terms and conditions for construction of an appropriately sized wastewater lift station, force main, 12-inch gravity wastewater main and appurtenances to provide wastewater service to the Rancho Alto development located south of Frate Barker Road at Rancho Alto Road, approximately 1,500 feet west of Manchaca Road. City cost reimbursement includes construction costs ("hard costs") in an amount not to exceed 40.2% or \$504,994, whichever is less, and an amount not to exceed 15% of the hard costs or \$72,179, whichever is less, for costs incurred by the developer for engineering, design and project management ("soft costs"), for an overall total cost reimbursement amount not to exceed \$577,173. Approve an Ordinance waiving the requirements of Section 25-9-61 of the City Code relating to eligible facilities and the maximum cost reimbursement of a facility and waiving the requirements of Section 25-9-63 of the City Code relating to amount of cost reimbursement. (Funding in the amount of \$577,173 is available in the Fiscal Year 2004-2005 Capital Budget of the Austin Water Utility.) (Recommended by the Water and Wastewater Commission)

The motion authorizing the negotiation and execution of a cost participation agreement and Ordinance No. 20050324-003 were approved.

- 4. Amend the Fiscal Year 2004-2005 Hotel/Motel Fund Operating Budget of Ordinance No 040913-01 to increase revenue by an amount of \$240,000 and to increase appropriations for the Tourism and Promotion Fund by an amount of \$240,000; and amend Tourism and Promotion Fund by increasing transfers in from the Hotel/Motel Fund by \$240,000 and increasing expense appropriations for Tourism and Promotion Contracts by \$240,000. (Funding is available from the increased revenue from Hotel/Motel Fund.) (Related Item 5)

  Ordinance No. 20050324-004 was approved.
- 5. Approve an amendment to the Austin Convention and Visitors Bureau (ACVB) Fiscal Year 2004-2005 Approved Marketing Plan and Budget by increasing the contract payment from the City of Austin to the ACVB by \$240,000 to \$5,155,586 and increasing the contract payment from the City of Austin to ΛCVB in the amount of \$240,000 to \$4,534,255 for the Fiscal Year 2004-2005. (Funding in the amount of \$240,000 is available in the Fiscal Year 2004-2005 Operating Budget of the Tourism and Promotion Fund.) (Related Item 4)

The motion authorizing the amendment to the Austin Convention and Visitors Bureau (ACVB) Fiscal Year 2004-2005 Approved Marketing Plan and Budget by increasing the contract was approved.

6. Approve a resolution revising and amending the Music Venue Relocation Program for Downtown Development established on April 15, 1999 under Chapter 380, Texas Local Government Code, and rename the program the Legendary Music Venue Relocation and Redevelopment Program. (Related Items 7, 8)

This item was postponed indefinitely and withdrawn from the agenda.

7. Authorize the negotiation and execution of an economic development agreement including a forgivable loan agreement and other documents with 4709 Incorporated d/b/a Midtown Live in an amount not to exceed \$750,000 under the Legendary Music Venue Relocation and Redevelopment Program for the redevelopment of property located at 7408 Cameron Road. (Funding is available in the Fiscal Year 2004-2005 Amended Operating Budget of the Downtown Development Fund.) (Related Items 6, 8)

This item was postponed indefinitely and withdrawn from the agenda.

8. Amend the Fiscal Year 2004-2005 General Fund Operating Budget of Ordinance No. 040913-01 to create a new line item entitled "Transfers Out to the Downtown Development Fund" in the amount of \$561,688; and to amend the Fiscal Year 2004-2005 Special Revenue Fund, the Downtown Development Fund, to appropriate the beginning balance of \$188,312, to create a new line item "Transfers In from the General Fund" in the amount of \$561,688, and to increase expenditure appropriations by \$750,000 to fund the Legendary Music Venue Relocation and Redevelopment Program. (Funding is available in the beginning balance of the General Fund, in the amount of \$509,465 from proceeds from the Liberty Lunch repayment and in the amount of \$52,223 from prior year savings.) (Related Items 6, 7)

This item was postponed indefinitely and withdrawn from the agenda.

- 9. Approve a resolution directing the City Manager to initiate the renaming of Old Bull Creek Road to West 35<sup>th</sup> Street. (The processing fee of \$500 has been determined, for one street sign location at the intersection of Old Bull Creek Road with Foothill Drive and West 35th Street as well as another street sign location at the intersection of Mount Bonnell Road and Old Bull Creek Road.)

  Resolution No. 20050324-009 was approved.
- 10. Approve an ordinance amending the Fiscal Year 2004-2005 Health and Human Services Department Operating Budget Special Revenue Fund of Ordinance No. 040913-01 to authorize the addition of one-half (0.5) full time equivalent position for the Refugee Health Screening Program for the provision of comprehensive health screening services to newly arriving official refugees. (Funding in the amount of \$169,209 is available from the Texas Department of State Health Services, Refugee Health Screening Program. The grant period is October 1, 2004 through September 30, 2005. This grant funding is included in the Fiscal Year 2004-2005 Health and Human Services Department Approved Operating Budget Special Revenue Fund.)

  Ordinance No. 20050324-010 was approved.

## Items 11 through 13 were pulled for discussion.

- 14. Approve an ordinance authorizing acceptance of \$99,250 in grant funds from the Texas Parks and Wildlife Department; and amending the Fiscal Year 2004-2005 Parks and Recreation Department Capital Budget of Ordinance No. 040913-02 to appropriate \$99,250 for construction of a hike and bike trail in Patterson Park. (Funding in the amount of \$99,250 will be provided by the Texas Parks and Wildlife grant proceeds. A fiscal note is attached; matching funds of \$24,813 are included in the Fiscal Year 2004-2005 Capital Budget of the Parks and Recreation Department.)

  Ordinance No. 20050324-014 was approved.
- 15. Authorize application for \$409,702 in grant funding from the U.S. Department of Justice, Bureau of Justice Assistance, Justice Assistance Program, to fund equipment for the Austin Police Department. (Funding is available from the U.S. Department of Justice, Bureau of Justice Assistance, Justice Assistance Program, for the grant period October 1, 2005 to September 30, 2006. A cash match is not required.) (Related Item 16)

The motion authorizing the application for \$409,702 in grant funding was approved.

16. Authorize an Interlocal Agreement between the City of Austin and Travis County to allow the City of Austin to accept and administer the Justice Assistance Grant Program on behalf of the Travis County Sheriff's Office. (Funding in the amount of \$409,702 is available from the Department of Justice, Bureau of Justice Assistance for the Justice Assistance Grant Program.) (Related Item 15)

The motion authorizing an Interlocal Agreement was approved.

- 17. Approve a resolution naming the weapons firing range at the Austin Police Academy located at 4800 Shaw Lane, Austin, Texas as the "Drew Alan Bolin Firing Range."

  Resolution No. 20050324-017 was approved.
- 18. Approve a resolution naming the police sub-station facility located at 404 Ralph Ablanedo Drive as the "Clinton Warren Hunter Police South Substation."

  Resolution No. 20050324-018 was approved.
- 19. Approve an ordinance on second reading only to renew the ROY'S TAXI, INC, taxicab franchise. (The taxicab permit fee of \$400 per year per permit is a revenue source. Expected annual revenue is \$62,000.)

The second reading of the ordinance was approved.

20. Approve an ordinance amending Section 12-4-63 of the City Code by adding a 20 miles per hour school zone speed limit to a portion of Rio Grande Street for Pease Elementary School and by amending the school zone on Doris Drive for Burnet Middle School; and amending Section 12-4-42 of the City Code by adding a portion of Cameron Road to the list of streets having a maximum speed limit of 40 miles per hour; and amending Section 12-4-44 of the City Code by adding a portion of Dessau Road to the list of streets having a maximum speed limit of 50 miles per hour. (Funding in the amount of \$10,600 is available in the Fiscal Year 2004-2005 Operating Budget of the Public Works Department.)

Ordinance No. 20050324-020 was approved.

21. Authorize execution of change order #6 to the construction contract with SHAW ENVIRONMENTAL, INC., Findlay, OH, for the North Service Center Excavation for Site Clearance in the amount of \$857,815, for a total contract amount not to exceed \$3,210,178.96. (Funding in the amount of \$857,815 is available in the Fiscal Year 2002-2003 Amended Capital Budget of the Austin Water Utility.) 7.05% MBE and 0.08% WBE subcontractor participation to date.

The motion authorizing the execution of change order #6 to the construction contract was approved.

- 22. Authorize execution of a construction contract with SOUTHWEST CORPORATION, Austin, TX, for Health and Human Services Department (HHSD) Phase II Building C Renovations for the Office of Vital Records in an amount not to exceed \$138,819. (Funding is available in the Fiscal Year 2004-2005 Amended Capital Budget of the Health and Human Services Department.) Lowest bid of two received. 12.72% MBE and 12.67% WBE subcontractor participation to date. The motion authorizing the execution of a construction contract was approved.
- Authorize negotiation and execution of a professional services agreement with DUNCAN ASSOCIATES, Austin, TX, for providing professional design-oriented planning services for the rewrite of Title 25 of the City Code, in an amount not to exceed \$300,000. (Funding is included in the Fiscal Year 2004-2005 Capital Budget of the Neighborhood Planning and Zoning Department.) Best qualification statement of six received. 16.5% MBE and 14.2% WBE subconsultant participation.

This item was postponed to April 14, 2005.

24. Authorize negotiation and execution of a professional services agreement with AGUIRRE, INC., Austin, TX, for construction phase services for the Austin-Bergstrom International Airport Terminal Baggage Screening Improvements Project in an amount not to exceed \$250,000. (Funding is available in Fiscal Year 2004-2005 Capital Budget of the Aviation Department.) Best qualification statement of eight received. This contract will be awarded in compliance with Chapter 2-9 of the City Code (Minority-Owned and Woman-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.

The motion authorizing the negotiation and execution of a professional services agreement was approved.

### Item 25 was pulled for discussion.

26. Authorize execution of a contract with MDA INSULATION, INCORPORATED, Odessa, TX, (MBE/MH-100%), for heat trace and insulation of Decker Unit 2 boiler in an amount not to exceed \$68,499. (Funding is available in the Fiscal Year 2004-2005 Amended Operating Budget of Austin Energy.) Lowest bid of two bids received. This contract will be awarded in compliance with Chapter 2-9 of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.

The motion authorizing the execution of a contract was approved.

27. Authorize execution of a contract with FLOWSERVE CORPORATION, Spicewood, TX, for the repair of the start-up boiler feedwater pump on Decker Unit #1 including replacement components in an amount not to exceed \$99,214. (Funding is available in the Fiscal Year 2004-2005 Amended Operating Budget of Austin Energy.) Lowest bid meeting specification of seven bids received. This contract will be awarded in compliance with Chapter 2-9 of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.

The motion authorizing the execution of a contract was approved.

28. Authorize execution of a contract with MGD TECHNOLOGIES INC., Dallas, TX, for the purchase of twenty wastewater flow meters for the Austin Water Utility in an amount not to exceed \$442,650. (Funding is included in the Fiscal Year 2004-2005 Approved Capital Budget of the Austin Water Utility.) Sole Source. This contract will be awarded in compliance with Chapter 2-9 of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.

The motion authorizing the execution of a contract was approved.

29. Authorize execution of 12-month supply agreement with POLYDYNE, INC., Riceboro, GA, for the purchase of liquid emulsion polymer for sludge dewatering for the Austin Water Utility in an amount not to exceed \$419,528.20, with two 12-month extension options in an amount not to exceed \$441,788.88 for the first extension option and \$465,761.92 for the second extension option, for a total contract amount not to exceed \$1,327,079. (Funding in the amount of \$209,764.10 is available in the Fiscal Year 2004-2005 Approved Operating Budget of the Austin Water Utility. Funding for the remaining six months of the original contract and extension options is contingent upon available funding in future budgets.) Lowest bid of four received. This contract will be awarded in compliance with Chapter 2-9 of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontract opportunities were identified; therefore, no goals were established for this solicitation.

#### The motion authorizing the execution of a supply agreement was approved.

30. Authorize execution of a 12-month supply agreement with MILLER UNIFORMS & EMBLEMS, INC., Austin, TX, for body armor for the Emergency Medical Services Department in an amount not to exceed \$67,300, with two 12-month extension options in an amount not to exceed \$67,300 per extension option, for a total agreement amount not to exceed \$201,900. (Funding in the amount of \$33,650 is available in the Fiscal Year 2004-2005 Approved Operating Budget for the Emergency Medical Services Department. Funding for the remaining six months of the original contract period and extension options is contingent upon available funding in future budgets.) Lowest bid meeting specification of six bids received. This contract will be awarded in compliance with Chapter 2-9 of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.

The motion authorizing the execution of a supply agreement was approved.

31. Authorize execution of a 12-month supply agreement with ORASURE TECHNOLOGIES, INC., Bethlehem, PA, for HIV-1 and HIV-1/2 Antibody Test Kits in an amount not to exceed \$125,000, with four 12-month extension options in an amount not to exceed \$125,000 per extension option, for a total agreement amount not to exceed \$625,000. (Funding in the amount of \$62,500 is available in the Fiscal Year 2004-2005 Approved Operating Budget of the Health and Human Services Department. Funding for the remaining six months of the original contract period and extension options is contingent upon available funding in future budgets.) Sole Source. This contract will be awarded in compliance with Chapter 2-9 of the City Code (Minority Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.

The motion authorizing the execution of a supply agreement was approved.

32. Authorize execution of a 12-month supply agreement with BAKER & TAYLOR, INC., Charlotte, NC, for the purchase of music compact discs for the Austin Public Library in an amount not to exceed \$145,860, with two 12-month extension options in an amount not to exceed \$145,860 per extension option, for a total agreement amount not to exceed \$437,580. (Funding in the amount of \$50,321.70 is available in the Fiscal Year 2004-2005 Approved Operating Budget of the Library Department. Funding in the amount of \$22,608.30 is available in the Fiscal Year 2004-2005 Approved Capital Budget of the Library Department. Funding for the remaining six months of the original contract period and extension options is contingent upon available funding in future budgets.) One bid received. This contract will be awarded in compliance with Chapter 2-9 of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.

This item was postponed to April 7, 2005.

33. Authorize execution of a 12-month service agreement with FLEET MAINTENANCE OF TEXAS, Austin, TX, for generator maintenance and repair services in an amount not to exceed \$189,319, with two 12-month extension options in amounts not to exceed \$134,635 for the first extension option and \$167,966 for the second extension option, for a total agreement amount not to exceed \$491,920. (Funding in the amount of \$94,659.50 is available in the Fiscal Year 2004-2005 Approved Operating Budgets of the departments as follows: Finance and Administrative Services (Building Services) \$13,946, Austin Energy \$7,389, Austin Fire Department \$32,359.50, Austin Water Utility \$19,329, Fleet Services \$5,771, Communications and Technology Management \$2,880.50, Wireless Communications Services \$9,579.50, Library Department \$1,655, and the Austin Convention Center \$1,750. Funding for the remaining six months of the original contract period and extension options is contingent upon available funding in future

budgets.) Lowest bid of five bids received. This contract will be awarded in compliance with Chapter 2-9 of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.

The motion authorizing the execution of a service agreement was approved.

34. Authorize negotiation and execution of a five-year revenue agreement with THE PEPSI BOTTLING GROUP, Austin, TX, for an exclusive beverage vending service agreement in an estimated revenue amount of \$3,362,879, with two 5-year extension options in an estimated revenue amount of \$10,088,637. (\$258,352 estimated revenue for Fiscal Year 2004-2005. Estimated revenue for the remaining 55 months of the original contract period and extension options is contingent on future volume of beverage consumption.) Best evaluated proposal of three proposals received. This contract will be awarded in compliance with Chapter 2-9 of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.

This item was postponed to April 14, 2005.

35. Amend the Fiscal Year 2004-2005 Watershed Protection and Development Review Department Operating Budget of Ordinance No. 040913-01 to increase the Drainage Utility Fund Beginning Balance by an amount of \$1,231,021, to increase Transfers Out to Other Enterprise CIP expense by an amount of \$800,000, and to increase the budgeted Drainage Utility Fund Ending Balance by an amount of \$413,021; amend the 2004-2005 Watershed Protection and Development Review Department Capital Budget of Ordinance No. 040913-02 to increase the transfer in from the Drainage Utility Fund Operating Budget to the Enterprise Capital Budget by an amount of \$800,000 and to appropriate \$800,000 to the Emergency Contingency Fund Project. (Funding in the amount of \$1,231,021 is available in the audited actual Fiscal Year 2004-2005 Drainage Utility Fund.)

C14H-04-0027 - Brown-Ledel-Silverman House - Approve second/third readings of an ordinance amending Chapter 25-2 of the Austin City Code by zoning property locally known as 609 West Lynn Street from multifamily residence moderate high density-neighborhood plan (MF-4-NP) combining district zoning to multifamily residence moderate high density-historic-neighborhood plan (MF-4-H-NP) combining district zoning. Conditions met as follows: No conditions were imposed on first ordinance reading. First reading on March 3, 2005. Vote: 4-3, Mayor Wynn, Council Member Dunkerley and Thomas nay. Applicant: Historic Landmark Commission. City Staff: Steve Sadowsky, Historic Preservation Office, Neighborhood Planning and Zoning Department, 974-6454. Note: A valid petition has been filed by the property owner in opposition to this rezoning request.

The motion to deny the multifamily residence moderate high density-historic-neighborhood plan (MF-4-H-NP) combining district zoning was approved on Council Member Dunkerley's motion, Mayor Wynn's second on a 5-2 vote. Those voting aye were: Mayor Wynn, Council Members Dunkerley, McCracken, Slusher and Thomas. Those voting nay were: Mayor Pro Tem Goodman and Council Member Alvarez.

Mayor Wynn recessed the Council Meeting to go into Executive Session at 5:21 p.m.

55. Conduct a public hearing and approve proposed design standards for commercial and retail development. (Reviewed by Design Commission, and to be reviewed by the Zoning and Platting Commission on 3/29/05, and the Planning Commission on 3/22/05.)

This item was postponed to April 14, 2005 on Council Member McCracken's motion, Mayor Wynn's second on a 6-0 vote. Council Member Slusher was off the dais.

56. Conduct a public hearing to consider a floodplain variance requested by Jill Rossi and Kerry Kimbrough to allow construction of an addition/house extension to an existing single-family residence in the 100-year floodplain of Shoal Creek at 7303 Greenhaven Drive.

The public hearing was closed on Council Member Thomas' motion, Council Member Dunkerley's second on a 7-0 vote.

Ordinance No. 20050324-056 was approved on Council Member McCracken's motion, Council Member Thomas' second on a 7-0 vote.

37. Approve an ordinance waiving the board and commission residency requirements, the prohibition against serving on multiple boards or commissions, and the nine-member limit on board and commission composition under Chapter 2-1 of the City Code, and appointment members to the Bond Advisory Committee. (Mayor Will Wynn, Mayor Pro Tem Jackie Goodman and Council Member Betty Dunkerley)

This item was postponed to April 7, 2005 on Council Member McCracken's motion, Council Member Thomas' second on a 7-0 vote.

12. Approve an ordinance on second/third reading amending Chapters 25-1, 25-2 and 25-6 of the Land Development Code to establish Transit Oriented Development districts, and adopting zoning and other regulations applicable in those districts. (Reviewed by Urban Transportation Commission, Design Commission, Planning Commission, and the Zoning and Platting Commission.) (Related Item 13)

There was a motion by Council Member Slusher to approve the second reading of the ordinance. This was seconded by Council Member Thomas.

There was a friendly amendment by Council Member Alvarez to add two amendments to the ordinance. First, Appendix D, page 11 would read as follows, "For stations located in neighborhood areas that have adopted neighborhood plans and that do not have defined gateway, midway and transition zones (e.g., Plaza Saltillo TOD), (A) Designate the Capital Metro owned property as the gateway." Second, amend Section 25-2-766, page 7, line 22 to read, "For stations located in neighborhood areas that have adopted neighborhood plans and that do not have defined gateway, midway and transition zones (e.g., Plaza Saltillo TOD), (B) Recognize the Citizens Advisory Group (CAG) appointed by the City and Capital Metro as the stakeholder group that is responsible for developing the (Plaza Saltillo TOD) station plan and, in the event that the station plan developed by the CAG deviates from the development restrictions that are currently in place, require that any such changes to the current restrictions be approved by the East Caesar Chavez Neighborhood Planning team." This was seconded by Mayor Pro Tem Goodman. This friendly amendment was not accepted by Council Member Slusher, maker of the main motion.

A substitute motion was offered by Council Member Alvarez, seconded by Mayor Pro Tem Goodman to approve the second reading of the ordinance with the following two amendments. First, Appendix D, page 11 would read as follows, "For stations located in neighborhood areas that have adopted neighborhood plans and that do not have defined

gateway, midway and transition zones (e.g., Plaza Saltillo TOD), (A) Designate the Capital Metro owned property as the gateway. Second, amend Section 25-2-766, page 7, line 22 to read, "For stations located in neighborhood areas that have adopted neighborhood plans and that do not have defined gateway, midway and transition zones (e.g., Plaza Saltillo TOD), (B) Recognize the Citizens Advisory Group (CAG) appointed by the City and Capital Metro as the stakeholder group that is responsible for developing the (Plaza Saltillo TOD) station plan and, in the event that the station plan developed by the CAG deviates from the development restrictions that are currently in place, require that any such changes to the current restrictions be approved by the East Caesar Chavez Neighborhood Planning team."

There was a friendly amendment by Mayor Pro Tem Goodman to amend the ordinance, Section 25-2-766, page 7, line 22 to read, "(A) The director shall prepare a station area plan for each transit oriented development (TOD) district. Capital Metropolitan Transportation Authority, neighborhood plan contact Team, if any, neighborhood associations, business and property-owners, and other affected persons to participate in the preparation of a station area plan." This was amended by Council Member Slusher to add, "any interested citizen" after the words, "other affected persons." This friendly amendment was later withdrawn by Mayor Pro Tem Goodman.

Council Member McCracken offered a substitute motion to read as follows, "Approve the second reading of the ordinance and direct staff to work with all the stakeholders in the neighborhood before the third reading of the ordinance to discuss possible revisions to the boundaries of the Plaza Saltillo TOD, as well as possible revisions to the processes for determining the final station area plan. This was seconded by Council Member Slusher with the following additional direction to staff:

- the area should not extend into the single family zoning;
- develop a process where everyone can participate.

Council Member Alvarez added further direction to staff:

- map out the station area plan;
- decide structure of the stakeholders group;
- define the process to develop the plan;
- ensure neighborhood input;
- mirror the neighborhood planning process;
- put in writing any situation where the TOD ordinance overrides neighborhood plans.

An additional friendly amendment was added by Council Member Slusher to amend Section 25-2-768 (B) to read as follows, "Amendments to a station area plan may be proposed by land owners not more than once per calendar year per property owned." This was accepted by the maker of the motion.

Council Member Slusher directed staff to review Section 25-2-754 (A) concerning the minimum height as it applies to sites of less than 8,000 or 9,000 square feet.

Council Member Alvarez directed staff to consider additional provisions in the ordinance that if a developer increased density, then the affordable requirement would apply.

Mayor Wynn adjourned the meeting at 9:00 p.m. without objection.

The minutes for the Regular Meeting of March 24, 2005 were approved on this the 7th day of April, 2005 on Council Member Alvarez' motion, Council Member McCracken's second on a 7-0 vote.

The minutes for the Regular Meeting of March 24, 2005 were amended and approved on May 19, 2005 on Council Member Alvarez' motion, Council Member Thomas' second on a 6-0 vote. Mayor Pro Tem Goodman was off the dais. The following amendment was made:

5. Approve an amendment to the Austin Convention and Visitors Bureau (ACVB) Fiscal Year 2004-2005 Approved Marketing Plan and Budget by increasing the contract payment from the City of Austin to the ACVB by \$240,000 to \$5,155,586 and increasing the contract payment from the City of Austin to ACVB in the amount of \$240,000 to \$4,534,255 for the Fiscal Year 2004-2005. (Funding in the amount of \$240,000 is available in the Fiscal Year 2004-2005 Operating Budget of the Tourism and Promotion Fund.) (Related Item 4)
