

MINUTES OF THE CITY COUNCIL

CITY OF AUSTIN, TEXAS

Regular Meeting

April 4, 1946
10:30

Council Chamber, City Hall

The meeting was called to order, with Mayor Miller presiding.

Roll call

Present: Councilmen Alford, Bartholomew, Mayor Miller, and Councilman Wolf

Present also: Guiton Morgan, City Manager; Trueman O'Quinn, City Attorney; J. E. Motheral, City Attorney; R. D. Thorp, Chief of Police.

Mrs. Beal Stone, 1810 Chicon Street, came before the Council regarding taxes on a piece of property she was contemplating purchasing, stating the taxes were more than the price on the property. The Mayor advised Mrs. Stone to contact the Tax Assessor and the City Manager, and they would work out something for her.

Pursuant to published notice thereof, the public hearing on the proposal of the City Council to amend the Zoning Ordinance in the following particulars:

- (1) To amend the USE designation of the following described property so as to change the same from "E" Heavy Industrial District and Third Height and Area District to "C-2" Commercial District and Third Height and Area District, to-wit:

Lot No. Eleven (11) and Lot No. Twelve (12),
Outlot No. 12, Division "C", Plat 25-B, in
the City of Austin, Travis County, Texas;

was duly opened at the appointed hour.

Mr. HORACE SHELTON, representing DOMENICO MILICIA; and MR. HAGE, LESSEE, appeared favoring this requested change. MR. THRASHER appeared in opposition for himself and also a negro EDGAR LEE, stating the approach to the City was dry; the rezoning would not add value to the property surrounding the location and that the negro had small children, and did not want this package store next door to him; and also that the Zoning Board had refused to grant this

change. Mayor Miller moved that in view of the fact Mr. Hage had other package stores, and since there was much opposition to package stores on the highways, and that there was opposition in the immediate territory, that the recommendation of the Zoning Board of Adjustment be adopted and that the change from "E" to "C-2" be NOT approved. AN ORDINANCE AMENDING THAT CERTAIN ORDINANCE PASSED BY THE CITY COUNCIL OF THE CITY OF AUSTIN, TEXAS, JULY 17, 1941, AND RECORDED IN ORDINANCE BOOK "L", PAGES 152-174, INCLUSIVE, OF THE ORDINANCE RECORDS OF THE CITY OF AUSTIN, WHICH ORDINANCE WAS AMENDATORY OF THAT CERTAIN ORDINANCE ESTABLISHING ZONING REGULATIONS AND DISTRICTS IN ACCORDANCE WITH A COMPREHENSIVE PLAN PASSED BY THE CITY COUNCIL APRIL 23, 1931, AND RECORDED IN ORDINANCE BOOK "I", PAGES 301-318, BOTH INCLUSIVE, OF THE ORDINANCE RECORDS OF THE CITY OF AUSTIN; THE AMENDATORY ORDINANCE HEREBY ENACTED CHANGING THE USE DESIGNATION FROM "A" RESIDENCE DISTRICT AND FIRST HEIGHT AND AREA DISTRICT TO "B" RESIDENCE DISTRICT AND SECOND HEIGHT AND AREA DISTRICT ON LOTS 1, 2, AND 3, BLOCK 2, OUTLOT 44, DIVISION "D", CITY OF AUSTIN, TRAVIS COUNTY, TEXAS; AND CHANGING THE USE DESIGNATION FROM "A" RESIDENCE DISTRICT AND FIRST HEIGHT AND AREA DISTRICT AND "C" COMMERCIAL DISTRICT AND SECOND HEIGHT AND AREA DISTRICT TO "D" INDUSTRIAL DISTRICT AND THIRD HEIGHT AND AREA DISTRICT ON A CERTAIN 3.56 ACRE TRACT OF LAND OUT OF OUTLOTS 15 and 16, in DIVISION "O", OF THE GOVERNMENT TRACTS ADJOINING THE CITY OF AUSTIN, TRAVIS COUNTY, TEXAS, AND BEING ALSO OUT OF OTHER LAND DESCRIBED IN BOOK 589, PAGES 313-336, OF THE DEED RECORDS OF TRAVIS COUNTY, TEXAS; AND ORDERING A CHANGE IN THE USE MAPS SO AS TO RECORD THE CHANGES HEREBY ORDERED; AND DECLARING AN EMERGENCY.

DEFINING NUISANCE PERSONAL PROPERTY BUT EXCEPTING HEREFROM LIVESTOCK, FOWLS AND DOGS; DIRECTING REMOVAL AND IMPOUNDING OF SAME WHEN FOUND IN PUBLIC PLACES; REDEMPTION BEFORE AND AFTER SALE; NOTICES OF SALE, POSTING AND SALE; CHARGES COLLECTIBLE BY CITY AND DISPOSITION OF PROCEEDS; KEEPING RECORDS HEREUNDER; VESTING ABSOLUTE TITLE IN AUCTION BUYER THIRTY (30) DAYS AFTER SALE WHEN NO REDEMPTION; BILLS OF SALE; DEFINING JUNK, DIRECTING ITS SALE AND DISPOSING OF PROCEEDS THEREOF; PROVIDING A SAVING CLAUSE, AND DECLARING AN EMERGENCY.

WHEREAS, the City Council has decided to provide lower domestic rates to consumers residing within the corporate limits of the City of Austin for a seven months period; namely, for water consumption on which bills are rendered between April 1 and October 31, 1946, for the purpose of furthering the garden program and the further beautification of the city; and

WHEREAS, it is the intention of the City Council that this reduction shall be made only to those water consumers whose use shall be strictly for residential purposes, and is not effective for commercial purposes; THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

THAT the City Manager be and he is hereby authorized and directed to make effective on all water readings within the corporate limits of the City of Austin, Texas, for all water consumers whose use is strictly for residential purposes, as of bills rendered between April 1 to October 31, 1946, at the following rates:

First	1,500 - 50 cents (minimum charge)
Next	2,000 - 30 cents per 1,000 gallons
Next	12,500 - 18 cents per 1,000 gallons
Next	34,000 - 14 cents per 1,000 gallons
Next	200,000 - 12 cents per 1,000 gallons
Over	250,000 - 12 cents per 1,000 gallons

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

THAT the City Council of the City of Austin hereby approves as a filling station site the property situated at the southeast intersection of East First Street and East Avenue, which property is owned by the Sinclair Oil Company and fronts 111 feet on East First Street and approximately 139 feet on East Avenue, and is designated as Lots 1 and 2, and the west 10 feet of Lot 3, Block 1, of a subdivision of Outlots 31 and 32 of the government outlots of the City of Austin, Travis County, Texas, and hereby authorizes the said Sinclair Oil Company, acting by and through A. F. Buck, District Manager, to construct, maintain and operate a drive-in gasoline filling station and to construct curbs, ramps and sidewalks in conjunction therewith, subject to the same being constructed in compliance with all the ordinances relating thereto, and further subject to the foregoing attached recommendations and plans, and the Building Inspector is hereby authorized to issue an occupancy permit for the operation of this filling station after full compliance with all the provisions of this resolution, and said permission shall be held to be granted and accepted subject to all necessary, reasonable and proper, present and future regulations and ordinances of the City of Austin, Texas, in the enforcement of the proper police, traffic and fire regulations, and the right of revocation is retained if, after hearing, it is found by the City Council that the said Sinclair Oil Company have failed and refused, and will continue to fail and refuse to perform any such conditions, regulations and ordinances.

Lots Three (3) to Twelve (12), inclusive in Block Four (4).

all of said lots being in the Mary Dawson Subdivision of Capitol Heights in the City of Austin, Travis County, Texas, which quitclaim deed is recorded in Vol. 569, Page 100, of the Deed Records of Travis County, Texas; and

WHEREAS, some question has been raised as to whether or not the said Guiton Morgan, as City Manager of the City of Austin, was authorized to execute the above described quitclaim deeds; Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN, TEXAS;
