MINUTES OF THE CITY COUNCIL

Regular Meeting

November 7,1946 11:00 A.M.

Council Chamber, City Hall

The meeting was called to order, with Mayor Miller presiding.

Roll call

Present : Councilmen Bartholomew, Glass, Mayor Miller, Councilman Wolf \_4 Absent : Councilman Thornberry - 1

Present also: Guiton Morgan, City Manager; J. E. Motheral, Director of Public Works; Trueman E. O'Quinn, City Attorney; and R. D. Thorp, Chief of Police.

The reading of the Minutes was dispensed with.

A petition by property owners on North Street asking for relief from excess water draining onto their property from Woodrow Avenue and a new addition east of Woodrow Avenue was received. The Director of Public Works reported that if easements could be obtained from property owners on north side of the street, the situation could be remedied; and the matter was referred to him for further attention.

J. M. Frazier appeared before the Council on behalf of the Independent Retail Grocers Association's petition for the sale of recombined milk in the City. It was the sense of the Council that a public hearing on the matter be called for Friday, November 15, at 7:30 P. M.

City Manager Morgan submitted the following tabulation of bids received on November 5 for the construction of paving, storm sewers, and sanitary sewers:

The base bid for paving was for 6" stabilized base with a 3 course penetration asphalt paving. Alternate "A" was for a $4\frac{1}{2}$ " hot mix asphaltic concrete base and 2" hot mix asphalt pavement. Alternate "B" was for monolithic concrete pavement, on which no bids were received.		
It is recommended that the contract for paving be awarded to Collins Construct- ion Company on the base bid for \$207,823.38 and if it is agreeable with the contractor to include a clause providing that we may use Alternate "A" con- struction on certain jobs where we feel it would be advantageous. If we cannot reach such an agreement with the contractor, I recommend that the contract be done on the basis of base bid stabilized base.		

On the Kinney Avenue storm sewer, it is recommended that the contract be awarded to the low bidder, Moore Construction Company, for \$81,503.03.

On the various storm sewer contracts, it is recommended that the contract be awarded to the low bidder, Collins Construction Company, for \$80,321.16

On Contract "A", Sanitary Sewers, it is recommended that the contract be awarded to the low bidder, T. H. Lee, for \$19,811.04.

Contracts "B" and "C" exceed our estimates by a considerable sum and if they are awarded to the low bidders an additional \$100,000.00 must be added to our 1947 budget as presented to you. If it is desirable to award the contracts, it is recommended that they be awarded to the low bidders - Contract "B" to Joe Bland Construction Company for \$165,464.20, and Contract "C" to Karl Wagner for \$206,811.86.

Councilman Glass offered the following resolution and moved its adoption:

(RESOLUTION)

WHEREAS, Texas Public Service Company has presented to the City Council tentative maps or plans showing the proposed construction of its gas mains in the streets in the City of Austin hereafter named, and said maps or plans have been considered by the City Council: therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

THAT Texas Public Service Company be, and the same is hereby, permitted to lay and construct its gas mains in and upon the following streets:

(1) A gas main in CONCORDIA AVENUE, from East 37th Street southerly 27 feet, the centerline of which gas main shall be 12.5 feet west of, and parallel to, the east property line of said Concordia Avenue.

Said gas main described above shall have a cover of not less than  $2\frac{1}{2}$  feet.

(2) A gas main in SINCLAIR AVENUE, from a point 170 feet south of West 49th Street, northerly 91 feet, the centerline of which gas main shall be 7.5 feet west of, and parallel to, the east property line of said Sinclair Avenue.

Said gas main described above shall have a cover of not less than  $2\frac{1}{2}$  feet.

(3) A gas main in SANTA ROSA STREET, from a point 163 feet east of Canadian Street westerly 144 feet, the centerline of which gas main shall be 6.5 feet south of, and parallel to, the north property line of said Santa Rosa Street.

Said gas main described above shall have a cover of not less than  $2\frac{1}{2}$  feet.

(4) A gas main in RAVINE DRIVE, from Academy Drive southerly 218 feet, the centerline of which gas main shall be 7.5 feet west of, and

parallel to, the east property line of said Ravine Drive.

Said gas main described above shall have a cover of not less than  $2\frac{1}{2}$  feet.

(5) A gas main in EAST 54TH STREET, from Bennett Avenue westerly 304 feet, the centerline of which gas main shall be 7.5 feet south of, and parallel to, the north property line of said East 54th Street.

Said gas main described above shall have a cover of not less than  $2\frac{1}{2}$  feet.

(6) A gas main in WEST 7TH STREET, from Lake Austin Boulevard to Newman Drive, the centerline of which gas main shall be 7.5' south of, and parallel to, the north property line of said West 7th Street.

Said gas main described above shall have a cover of not less than  $2\frac{1}{2}$  feet.

(7) A gas main in NEWMAN DRIVE, from West 7th Street northerly 171 feet, the centerline of which gas main shall be 6 feet west of, and parallel to, the east property line of said Newman Drive.

Said gas main described above shall have a cover of not less than  $2\frac{1}{2}$  feet.

(8) A gas main in CLEARVIEW DRIVE, from a point 277 feet west of Exposition Boulevard easterly 53 feet, the centerline of which gas main shall be 7.5 feet south of, and parallel to, the north property line of said Clearview Drive.

Said gas main described above shall have a cover of not less than  $2\frac{1}{2}$  feet.

(9) A gas main in GLENDALE AVENUE, from a point 347 feet north of East Live Oak Street, northerly 144 feet, the centerline of which gas main shall be 7.5 feet west of, and parallel to, the east property line of said Glendale Avenue.

Said gas main described above shall have a cover of not less than  $2\frac{1}{2}$  feet.

(10) A gas main in WEST 34th Street, from a point 167 feet west of Jefferson Street, easterly 92 feet, the centerline of which gas main shall be 7.5 feet south of, and parallel to, the north property line of said West 34th Street.

Said gas main described above shall have a cover of not less than  $2\frac{1}{2}$  feet.

(11) A gas main in ASHBY STREET, from Bluebonnet Lane to Buford Street, the centerline of which gas main shall be 7.5 feet south of, and parallel to, the north property line of said Ashby Street.

Said gas main described above shall have a cover of not less than  $2\frac{1}{2}$  feet.

- (12) A gas main in AVENUE F, from a point 225 feet south of East 53rd Street, northerly 448 feet, the centerline of which gas main shall be 12 feet west of, and parallel to, the east property line of said Avenue F.
  - Said gas main described above shall have a cover of not less than  $2\frac{1}{2}$  feet.
- (13) A gas main in BOWMAN AVENUE, from a point 5 feet east of Exposition Boulevard easterly 125 feet, the centerline of which gas main shall be 7.5 feet south of, and parallel to, the north property line of said Bowman Avenue.

Said gas main described above shall have a cover of not less than  $2\frac{1}{2}$  feet.

(14) A gas main in OAKNONT BOULEVARD, from a point north of West 36th Street south to West 36th Street, the centerline of which gas main shall be 13.5 feet west of, and parallel to, the east property line of said Oakmont Boulevard.

Said gas main described above shall have a cover of not less than  $2\frac{1}{2}$  feet.

(15) A gas main in WEST 36TH STREET, from Oakmont Boulevard westerly 221 feet, the centerline of which gas main shall be 13.5 feet south of, and parallel to, the north property line of said West 36th Street.

Said gas main described above shall have a cover of not less than  $2\frac{1}{2}$  feet.

(16) A gas main in BLUEBONNET LANE, from Collier Street southerly 118 feet, the centerline of which gas main shall be 13.5 feet west of, and parallel to, the east property line of said Bluebonnet Lane.

Said gas main described above shall have a cover of not less than  $2\frac{1}{2}$  feet.

The Texas Public Service Company is hereby put upon notice that the City of Austin does not guarantee that the space assigned above is clear from other underground utilities, but is based upon the best records we have at hand, and that the minimum depth stated does not have any reference to the fact that greater depths may not be required at special points. When the Texas Public Service Company requires definite information upon the ground as to elevations or working points from which to base the location of their assignments, they shall apply to the Director of Public Works not less than three (3) days before such information is required. The Texas Public Service Company is further put upon notice that they will be required to bear the expense of repairs or replacement of any underground utility damaged during the construction of lines named in this resolution.

And that whenever pavement is cut in the vicinity of a fire plug, water must be used at intervals during the course of backfilling of the ditches.

That the work and laying of said gas mains, including the excavation in the streets and the restoration and maintenance of said streets after said

5. Contract "B", sanitary sewers, construction by Joe Bland Construction Company, at a cost of \$165,464.20, to be paid by the City of Austin out of the General Fund, which fund will be reimbursed from sanitary sewer bond fund after the sale of bonds authorized under Proposition 11 at an election held May 7, 1946.
