WHEREAS, the City of Austin taxes for the years 1941, 1942, 1943, and 1944, were rendered in the name of C. W. Heath on W. 78° of Lots 3 and 4, Block 2, Pleasant Grove, Plat 77. Item 67, in the City of Austin, Travis County, Texas; said taxes for said years being in the amount of \$127.05

and for non-payment of same at maturity, penalty in the sum of \$6.35 has been assessed, and interest in the amount of \$14.15 has accrued, making the total amount of taxes, penalty and interest due \$147.55; and

WHEREAS, the City Council of the City of Austin deems it just and equitable to remit said penalty in the sum of \$6.35 and one-half of the interest in the sum of \$7.07; therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

THAT the aforesaid penalty in the sum of \$6.35 and one-half of the interest in the sum of \$7.07 are hereby remitted, and the Tax Assessor and Collector of the City of Austin is hereby authorized and directed to charge said penalty in the sum of \$6.35 and said interest in the sum of \$7.07 off his rolls, and to issue to the party entitled to receive same a receipt in full upon the payment of the taxes and one-half of the interest as aforesaid.
