MR. TRUEMAN E. O'QUINN, representing MR. M. H. CROCKETT, SR., and MR. MOTON CROCKETT, JR., appeared before the Council regarding the zoning application at 1000 and 1100 blocks U.S. Highway No. 290 or Texas State Highway No. 20, from "A" to "C". Action had been postponed in the Planning Commission until an adequate development plan with streets and necessary outlets was presented for consideration. The file was not before the Council, but MR. O'QUINN and MR. CROCKETT wanted to clarify any questions and to give what information they had available. Mr. Crockett stated he would be glad to dedicate a street from Sheridan Avenue to State Highway No. 20, at a 90° angle at the same width as Sheridan Avenue.

There being no further business the Council adjourned, subject to the call of the Mayor.
