The meeting was called to order, with Mayor Miller presiding.

WRIGHT STUBBS, attorney for JOE WILSON SMALL, appeared before the Council to appeal his client's application for a taxicab driver's permit. After considering the appeal, it was the sense of the Council that the application be denied.
