The meeting was called to order with Mayor Drake presiding.

Councilman White offered the following resolution and moved its adoption: (RESOLUTION)

WHEREAS, Southern Union Gas Company has presented to the City Council tentative maps or plans showing the proposed construction of its gas mains in the streets in the City of Austin hereafter named, and said maps or plans have been considered by the City Council; therefore

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

THAT Southern Union Gas Company be and the same is hereby permitted to lay and construct its gas mains in and upon the following streets:

(1) A gas main in EAST llTH STREET, from a point 252 feet east of Lincoln Street easterly to a point 72 feet west of Prospect Avenue, the centerline of which gas main shall be 22 feet south of and parallel to the north property line of said EAST llTH STREET.

Said gas main described above shall have a cover of not less than  $2\frac{1}{2}$  feet.

(2) A gas main in NORTHEAST DRIVE, from Betty Cook Drive easterly 675 feet, the centerline of which gas main shall be 6.5 feet south of and parallel to the north property line of said NORTHEAST DRIVE.

Said gas main described above shall have a cover of not less than  $2\frac{1}{2}$  feet.

(3) A gas main in ARNOLD DRIVE, from a point 15 feet north of Northeast Drive southerly 998 feet, the centerline of which gas main shall be 6.5 feet west of and parallel to the east property line of said ARNOLD DRIVE.

Said gas main described above shall have a cover of not less than  $2\frac{1}{2}$  feet.

(4) A gas main in BETTY COOK DRIVE, from a point 265 feet south of Emory Lane southerly 221 feet, the centerline of which gas main shall be 6.5 feet west of and parallel to the east property line of said BETTY COOK DRIVE.

Said gas main described above shall have a cover of not less than  $2\frac{1}{2}$  feet.

(5) A gas main in JACK COOK DRIVE, from Betty Cook Drive easterly 451 feet, the centerline of which gas main shall be 6.5 feet south of and parallel to the north property line of said JACK COOK DRIVE.

Said gas main described above shall have a cover of not less than  $2\frac{1}{2}$  feet.

(6) A gas main across Airport Boulevard at Middle Fiskville Road.

Said gas main described above shall have a cover of not less than  $2\frac{1}{2}$  feet.

(7) A gas main in MIDDLE FISKVILLE ROAD, from Airport Boulevard southerly 280 feet, the centerline of which gasmain shall be 6.5 feet west of and parallel to the east property line of said MIDDLE FISKVILLE ROAD.

Said gas main described above shall have a cover of not less than  $2\frac{1}{2}$  feet.

(8) A gas main in HEMLOCK AVENUE, from a point 35 feet south of Walnut Avenue southerly 100 feet, the centerline of which gas main shall be 7.5 feet west of and parallel to the east property line of said HEMLOCK AVENUE.

Said gas main described above shall have a cover of not less than  $2\frac{1}{2}$  feet.

(9) A gas main in HARDY DRIVE, from Richcreek Road to St. Joseph Boulevard, the centerline of which gas main shall be 6.5 feet west of and parallel to the east property line of said HARDY DRIVE.

Said gas main described above shall have a cover of not less than  $2\frac{1}{2}$  feet.

(10) A gas main in ST. JOSEPH BOULEVARD, from Hardy Drive westerly 196 feet, the centerline of which gas main shall be 6.5 feet south of and parallel to the north property line of said ST. JOSEPH BOULEVARD.

Said gas main described above shall have a cover of not less than  $2\frac{1}{2}$  feet.

(11) A gas main in POQUITO STREET, from East 12th Street northerly 111 feet, the centerline of which gas main shall be 6.5 feet west of and parallel to the east property line of said POQUITO STREET.

Said gas main described above shall have a cover of notless than  $2\frac{1}{2}$  feet.

(12) A gas main in CORONADO STREET, from Pedernales Street westerly 154 feet, the centerline of which gas main shall be 6.5 feet south of and parallel to the north property line of said CORONADO STREET.

Said gas main described above shall have a cover of not less than  $2\frac{1}{2}$  feet.

(13) A gas main in KERR STREET, from Bluebonnet Lane to Garner Avenue, the centerline of which gas main shall be 6.5 feet south of and parallel to the north property line of said KERR STREET.

Said gas main described above shall have a cover of not less than  $2\frac{1}{2}$  feet.

(14) A gas main in BLUEBONNET LANE, from a point 410 feet south of Dexter Street north to Kerr Street, the centerline of which gas main shall be 6.5 feet east of and parallel to the west property line of said BLUEBONNET LANE.

Said gas main described above shall have a cover of not less than  $2\frac{1}{2}$  feet.

(15) A gas main in DEXTER STREET, from Robert E. Lee Road to Garner Avenue, the centerline of which gas main shall be 6.5 feet south of and parallel to the north property line of said DEXTER STREET.

Said gas main described above shall have a cover of not less than  $2\frac{1}{2}$  feet.

(16) A gas main in TREADWELL STREET, from Folts Avenue to Garner Avenue, the centerline of which gas main shall be 6.5 feet south of and parallel to the north property line of said TREADWELL STREET.

Said gas main described above shall have a cover of not less than  $2\frac{1}{2}$  feet.

(17) A gas main in FOLTS AVENUE, from Dexter Street to Treadwell Street, the centerline of which gas main shall be 6.5 feet east of and parallel to the west property line of said FOLTS AVENUE.

Said gas main described above shall have a cover of not less than  $2\frac{1}{2}$  feet.

(18) A gas main in LUND STREET, from Dexter Street to Robert E. Lee Road, the centerline of which gas main shall be 6.5 feet north of and parallel to the south property line of said LUND STREET.

Said gas main described above shall have a cover of not less than  $2\frac{1}{2}$  feet.

(19) A gas main in ROBERT E. LEE ROAD, from a point 323 feet west of Dexter Street easterly 1306 feet, the center-line of which gas main shall be 12.5 feet north of and parallel to the south property line of said ROBERT E. LEE ROAD.

Said gas main described above shall have a cover of not less than  $2\frac{1}{2}$  feet.

(20) A gas main in WEST 46TH STREET, from a point 55 feet east of Shoal Creek Boulevard westerly 62 feet, the centerline of which gas main shall be \$5.5 feet south of and parallel to the north property line of said WEST 46TH STREET.

Said gas main described above shall have a cover of not less than  $2\frac{1}{2}$  feet.

(21) A gas main in SHOAL CREEK BOULEVARD, from West 46th Street southerly 99 feet, the centerline of which gas main shall be 6.5 feet west of and parallel to the east property line of said SHOAL CREEK BOULEVARD.

Said gas main described above shall have a cover of not less than  $2\frac{1}{2}$  feet.

The Southern Union Gas Company is hereby put upon notice that the City of Austin does not guarantee that the space assigned above is clear from other underground utilities, but is based upon the best records we have at hand, and that the minimum depth stated does not have any reference to the fact that greater depths may not be required at special points. When the Southern Union Gas Company requires definite information upon the ground as to elevations or working points from which to base the location of their assignments, they shall apply to the Department of Public Works not less than three (3) days before such information is required. The Southern Union Gas Company is further put upon notice that they will be required to bear the expense of repairs or replacement of any underground utility damaged during the construction of lines named in this resolution.

AND THAT whenever pavement is cut in the vicinity of a fire plug, water must be used at intervals during the course of backfilling of the ditches.

THAT the work and laying of said gas mains, including the excavation in the streets, and the restoration and maintenance of said streets after said mains have been laid shall be under the supervision and direction of the City Manager, and under all the pertinent terms and conditions of the certain franchises granted to said company by the City of Austin.

Re: Bergstrom Air Force Base, Texas

"Dear Mayor Drake:

"It has been determined by the Department of the Air Force that, because it is considered a permanent installation, it is desirable that the indefeasible fee simple title to the lands upon which Bergstrom Air Force Base is located be vested in the United States.

"Will you kindly advise if the City of Austin is agreeable to donating and quitclaiming to the United States such right, title, interest and estate as it may now possess as a result of its having furnished funds used in acquiring subject lands.

Sincerely yours, (S) H. R. HALLOCK Colonel, CE District Engineer"

Councilman White moved that this matter be referred to the City Attorney for a legal opinion to the present title the City now owns, before taking any action. The motion, seconded by Councilman Johnson, carried by the following vote:

Councilman MacCorkle inquired about some items in the Budget. It was decided to have a meeting at 2:30 Monday, December 22nd, with the City Manager and major Department heads to discuss the budget.

Councilman MacCorkle inquired about the inspection fees charged dairies located from fifty to a hundred miles from Austin. The Health Officer stated there were no fees charged for inspections, but only a license fee. In some cases, other City Health Officers' inspections and recommendations were used. The City Manager stated a study was underway on this and some other fee charges out of the Health Department.

Councilman White asked if some sort of shelter could be provided for the patrolman who stands at the corner of Congress and 1st Street to regulate the traffic light there. He stated the patrolman had to stand out in all sorts of weather. The City Manager explained that the patrolmen had not wanted that, as it would obstruct their view.

DR. E. H. GIVENS appeared before the Council. He introduced the new President of Huston Tillotson College. Dr. Givens asked for permission to use Rosewood Park for the WESTERN STATE SHOWS from March 20-28 for the boy scouts. Councilman Long moved that March 20-28 be set out for the WESTERN STATE SHOWS for the boy scouts as requested. The motion, seconded by Councilman Johnson, carried by the following vote:

DR. GIVENS thanked the Council for hiring three negro firemen, and he reported there were several to take the examination to fill the other places. He asked that an additional park be provided out of the \$200,000 Park Fund this year and that Olive Street Park be equipped. He asked that more information be made available on the revenue bond issue that will be presented. He asked that something be provided for the areas in South Austin and West Austin for playgrounds. DR. GIVENS asked for a street light at 17th and Chestnut, and traffic lights at 12th and San Bernard; Rosewood and Chicon; 11th and Rosewood.

MRS. VAN DYKE, introduced by Dr. Givens, appeared in behalf of the branch library at Hackberry and Angelina. She stated Miss King, the director, was taken away so much to visit 12 stations including the schools in that area, and several mornings the library was closed. She stated they needed someone there to help issue the books, and she was appealing to the Council for an assistant

to increase the service. The Council replied that it was having a meeting to study the budget, and at this time it was not able to say what had been included for these different projects.
