

MINUTES OF THE CITY COUNCIL

CITY OF AUSTIN, TEXAS

Regular Meeting

April 17, 1952
10:00 A.M.

Council Chamber, City Hall

The meeting was called to order with Mayor Drake presiding.

Roll Call:

Councilman White moved that the minutes of the last meeting be approved. The motion, seconded by Councilman MacCorkle, carried by the following vote:

Councilman Long offered the following resolution and moved its adoption:

(RESOLUTION)

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

That Frank Morgan, an individual doing business as AMERICAN TAXI COMPANY, the present owner and holder of a taxicab franchise from the City of Austin under the terms of the Taxicab Ordinance of the City of Austin, be and he is hereby authorized to include said franchise along with the other assets of the American Taxi Company in a mortgage to K. M. Fisher of San Antonio, Texas, and that in the event of foreclosure of said mortgage, the transfer of such franchise to the said K. M. Fisher is hereby approved.

The motion, seconded by Councilman White, carried by the following vote:

MR. C. T. JOHNSON appeared before the Council asking permission to erect a banner for the Billy Graham Crusade. Councilman MacCorkle moved that permission for the erection of a banner between two lights posts on the Capitol grounds for the Billy Graham Crusade be granted as requested by MR. C. T. JOHNSON, the banner to be erected under the direction of the Engineering Department. The motion, seconded by Councilman Long, carried by the following vote:

Mr. Perry Jones, representing Mr. B. M. Gafford, requested the Council to revoke a boat-dock permit granted to MR. MARION FOWLER, as the docks he is working on are in violation of the City ordinance. MR. TRUEMAN E. O'QUINN represented Mr. Fowler. After much discussion, Councilman MacCorkle stated it was his impression that the city's property rights had been infringed upon, and that if the remaining of these docks are constructed, the ordinance would be violated. Mayor Drake stated there were some problems that were legal, and that the Council should not have to pass on. Councilman Long moved that the permit for the building of the additional boat docks be revoked since the construction of the remaining docks would be in violation of the existing ordinance. The motion, seconded by Councilman White, carried by the following vote:

The Mayor announced that the permit had been revoked in accordance with the motion, which passed by a three to two vote.

MR. S. M. APPERSON, Southern Union Gas Company, appeared in the interest of amending the plumbing code so that a gas utility man with not less than five years' experience would be included on the Plumbing Board of Appeals.

The following amendments were discussed and accepted by the Council:

That such ordinance be amended in Section 4 thereof so that said section 4 shall read as follows:

SECTION 4. Qualifications of Plumbing Inspectors. The Plumbing Inspector and every assistant shall have had experience as plumbers in a supervisory capacity, for not less than five (5) years, and shall be licensed plumbing inspectors and shall reside in the City of Austin.

That such ordinance be amended in the first paragraph of Section 8 so that said paragraph shall read as follows:

SECTION 8. Testing Installations. No water, gas, soil, drain, or vent pipe shall be covered from view or concealed until after the work has been tested, inspected, and approved by the Plumbing In-

spector. If any part of the work is covered before being inspected and approved, it shall be uncovered at the expense of the permittee. When rough-in is complete, the entire water and drainage system, including the house sewer, shall be prepared for inspection, if conditions permit. Soil and waste stacks shall be plugged and filled with water to the highest point, and all joints shall be made water tight. Any defective material shall be replaced with sound material, and water tests shall be repeated until the work is found to be tight and to conform to the requirements of this Ordinance. The use of cement, sealing wax, rosin, paint, tallow, or other material or agency which may prevent, or in any way tend to prevent, the detection of any cracks, sand holes, or other imperfections in any material used in plumbing is prohibited.

That such ordinance be amended in Section 18 thereof so that said Section shall read as follows:

SECTION 18. Plumbing Board of Appeals Created. The Plumbing Board of Appeals of the City of Austin is hereby created. Said Board shall consist of eight (8) voting members, which shall include one licensed Master Plumber having not less than ten (10) years active and continuous experience as a Supervising Plumber; a licensed Journeyman Plumber having not less than five (5) years active and continuous experience; and Appliance Dealer with five (5) years experience; a Mechanical Engineer having not less than five (5) years experience in the installation and operation of plumbing, heating, and air conditioning; an Architect maintaining his own office in active practice for five (5) years, a Property Owner; an Air Conditioning Contractor with five (5) years experience; and a gas utility man with not less than five (5) years' experience. The Plumbing Inspector shall be an Ex Officio member. All members of the Board shall be nominated by the City Manager and appointed by the City Council, and shall hold office for two (2) years from date of their appointment or until their successors have been appointed and qualified. Members of the Plumbing Board of Appeals shall receive no compensation for their services on said Board.

That such ordinance be amended in Section 22, subsection 17 thereof so that said subsection 17 of Section 22 shall read as follows:

(17) Tapped soil fittings will be permitted and the waste pipe arm between tapped tee and water seal of trap shall be of not less than one and one-half inch ($1\frac{1}{2}$ ") brass pipe (iron pipe size), and well reamed, or lead pipe. The use of solder bushings or inverted joints in waste lines is prohibited, except where solder nipple is wiped to a lead connection.

That such ordinance be amended in Section 22, subsection 31 thereof so that the paragraph entitled SIZE AND LENGTH OF BRANCH AND INDIVIDUAL VENTS, which immediately follows Table B, shall read as follows:

SIZE AND LENGTH OF BRANCH AND INDIVIDUAL VENTS. Individual and relief vents shall not be less than $1\frac{1}{2}$ " in diameter. For $1\frac{1}{2}$ " wastes, the vent shall be of the same diameter as the waste pipe. For 2" or larger vents, the vent shall not be reduced by more than one pipe

size, except that not more than one water closet, on a 4" branch waste not over 30' in length, may have a 2" vent.

That such ordinance be amended in Section 22, subsection 51 thereof so that said subsection 51 of Section 22 shall read as follows:

(51) All waterpipes from water meters to and through a building used for supplying plumbing fixtures and water system shall be wrought iron galvanized; merchant steel galvanized; brass pipe (iron pipe size and weight); lead (extra strong); copper (Types K and L); or cast iron.

That such ordinance be amended in Section 22, subsection 65 thereof so that the first sentence in subsection 65 of Section 22 shall read as follows:

(65) All water heaters shall be provided with suitable cut-off valves on the cold water supply and gas supply, a drain cock to drain tank, and a safety relief valve, of pressure and temperature construction, located on the heater side of the cut-off within six inches (6") of the water heater on the cold water connection.

Mayor Drake brought up the following amended ordinance for its third and final reading:

AN ORDINANCE REGULATING PLUMBING AND GAS FITTING WORK; PROVIDING FOR ENFORCEMENT OF THIS ORDINANCE; REQUIRING PERMITS AND PRESCRIBING FEES FOR PLUMBING AND GAS FITTING; PRESCRIBING SPECIFICATIONS FOR PLUMBING INSTALLATIONS, GAS PIPING AND GAS APPLIANCES; PROVIDING PENALTIES FOR VIOLATIONS OF THIS ORDINANCE; PROVIDING A SEVERABILITY CLAUSE; REPEALING CERTAIN ORDINANCES AND ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH; AND DECLARING AN EMERGENCY.

The ordinance was read the third time, and Councilman White moved that the ordinance as amended be finally passed. The motion, seconded by Councilman Johnson, carried by the following vote:

No one appeared in opposition. The Mayor asked that all those in favor of following the recommendation of the Zoning Board and granting the requested change vote "aye"; those opposed, vote "no". Roll call showed the following vote:

MR. ARNOLD E. WITTMAN, 804 E. 45th, expressed opposition on the basis the plan was not well understood, and asked the council to continue this hearing at a later time when more people could be present. MR. REUBEN FRANKE, 1005 E. 45th expressed opposition; MR. G. L. HUCKABY, 45th and Avenue B, stated this would nullify his building on more of this lot at this location; MRS. FRED NORMAN, 1007 E. 45th, did not want to pay for the heavy thoroughfare paving; MRS. VEST LANDER inquired about zoning and deed restrictions. The Council took no action on the proposal and the Mayor announced the hearing would be continued at a later date.

In view of the fact no action was taken on the above property, and one lot listed in the area, was included in the recommendation of the Zoning Commission with reference to the application of C. BEN HIBBETTS, et al, 4308-14 & 4406 Morningside Avenue, the Council decided to omit that one lot, Lot 12, Block 4 from the Ordinance, as well as the part pertaining to 45th Street.

The Mayor then introduced the following ordinance:

AN ORDINANCE AMENDING THAT CERTAIN ORDINANCE PASSED BY THE CITY COUNCIL OF THE CITY OF AUSTIN, TEXAS, JULY 17, 1941, AND RECORDED IN ORDINANCE BOOK "L", PAGES 152-174, INCLUSIVE, OF THE ORDINANCE RECORDS OF THE CITY OF AUSTIN, WHICH ORDINANCE WAS AMENDATORY OF THAT CERTAIN ORDINANCE ESTABLISHING ZONING REGULATIONS AND DISTRICTS IN ACCORDANCE WITH A COMPREHENSIVE PLAN PASSED BY THE CITY COUNCIL APRIL 23, 1931, AND RECORDED IN BOOK "I", PAGES 301-318, INCLUSIVE, OF THE ORDINANCE RECORDS OF THE CITY OF AUSTIN, THE AMENDATORY ORDINANCE HEREBY CHANGING THE HEIGHT AND AREA DESIGNATION FROM ITS PRESENT HEIGHT AND AREA DISTRICT TO FIFTH HEIGHT AND AREA DISTRICT ON ALL LOTS, PARCELS OF LAND AND ACREAGE WHICH LIE WITHIN A LINE ESTABLISHED 150 FEET BACK FROM AND PARALLEL WITH THE WEST RIGHT-OF-WAY LINE OF LAMAR BOULEVARD, SITUATED BETWEEN THE NORTH STREET LINE OF WEST 39TH STREET AND THE SOUTH STREET LINE OF WEST 42ND STREET; AND ALL LOTS, PARCELS OF LAND AND ACREAGE WHICH LIE WITHIN A LINE ESTABLISHED 150 FEET BACK FROM AND PARALLEL WITH THE WEST RIGHT-OF-WAY LINE OF LAMAR BOULEVARD AND SITUATED BETWEEN THE NORTH STREET LINE OF WEST 42ND STREET AND THE SOUTH STREET LINE OF WEST 45TH STREET, EXCEPT LOT 12, BLOCK 4, ALTA VISTA ADDITION, ALL IN THE CITY OF AUSTIN, TRAVIS COUNTY, TEXAS; ORDERING A CHANGE IN THE HEIGHT AND AREA MAPS SO AS TO RECORD THE CHANGES HEREBY ORDERED; AND SUSPENDING THE RULE REQUIRING THE READING OF ORDINANCES ON THREE SEPARATE DAYS.

AN ORDINANCE DECLARING THE NECESSITY FOR AND ORDERING THE PAVING AND IMPROVEMENT OF CERTAIN STREETS OR PORTIONS THEREOF IN THE CITY OF AUSTIN, APPROVING PLANS AND SPECIFICATIONS FOR SUCH WORK, AUTHORIZING THE CITY MANAGER TO ADVERTISE FOR BIDS, DIRECTING THE PREPARATION OF ESTIMATES, INVOKING THE PROCEDURE PROVIDED BY ARTICLE XXIV OF THE CITY CHARTER AND CHAPTER 106 OF THE ACTS OF THE FIRST CALLED SESSION OF THE 40th LEGISLATURE OF TEXAS, DETERMINING THAT A PART OF THE COSTS SHALL BE BORNE BY THE CITY AND THAT A PART SHALL BE BORNE BY THE ADJUTING PROPERTIES AND THE OWNERS THEREOF, PROVIDING FOR THE ASSESSMENT OF THE PORTIONS OF THE COSTS TO BE BORNE BY PROPERTY OWNERS, AND FOR THE FIXING OF A LIEN TO SECURE PAYMENT OF SUCH ASSESSMENTS, STATING THE TIME AND MANNER PROPOSED FOR PAYMENT OF ALL SUCH COSTS, DIRECTING THE CITY CLERK TO CAUSE A NOTICE OF THE ENACTMENT OF THIS ORDINANCE TO BE FILED IN THE MORTGAGE OR DEED OF TRUST RECORDS OF TRAVIS COUNTY, TEXAS, AND DECLARING AN EMERGENCY.


