That in compliance with request of the Board of Equalization herewith attached, the Assessor and Collector be and he is hereby instructed to change on his tax rolls of 1921 the valuation of \$3,335.00 placed by said Board on the improvements on the Southeast 23x280 feet of Lot 5, Block 71, to \$3,000.00 as corrective in line with other adjoining improvements, the Board admitting error in making the valuation of \$3,335.00, and the Assessor and Collector is authorized to take credit for \$335.00, the amount of reduction.

That the Assessor and Collector be and he is hereby instructed to make said reduction and correction on his rolls for 1921 and to take credit for \$725.00, amount of reduction.
