

SPECIAL MEETING OF THE CITY COUNCIL:

Austin, Texas, December 31, 1934.

The meeting was called to order with Mayor Pro tem Wolf presiding. Roll call showed the following members present: Councilmen C. F. Alford, Simon Gillis, and Mayor Pro tem Wolf, 3; absent, Councilman C. M. Bartholomew and Mayor Tom Miller, 2.

The City Manager submitted a letter from Julian Montgomery, State Engineer, PWA, advising that the contract for the 36" main outfall sewer, PWA Docket 2863, Eng. Ref. No. 68a, must be awarded on the basis of machine labor as the construction of the project by hand labor would increase the cost approximately \$17,000.00.

The following report of the engineering staff was then read:
