City of Austin from any claims for damages to any person or property that may accrue to or be brought by any person by reason of the exercise of the privileges granted the Contractor by the City of Austin and shall guarantee the replacement of all sidewalks, pavement and all other public property and public utilities disturbed or removed during the construction work and shall further guarantee the construction of a walkway and other safeguards during the occupancy of the space.

The resolution was adopted by the following vote: Ayes, Councilmen Bartholomew, Gillis, Mayor Miller, and Councilman Wolf, 4; nays, none; Councilman Alford absent, 1.

The written request of Joe Prowse for remission of interest and penalty accruing on delinquent taxes against four lots owned by him located east of the Farmers Oil Mill on lower East 7th Street was referred to the City Attorney for recommendation.

The Council granted permission to the King's Daughters to use the auditorium of the Austin Public Library on May 21st and May 22nd.

Mayor Pro tem Wolf laid before the Council the following resolution:

THAT the sum of \$1.50 be and the same is hereby appropriated out of the General Fund, not otherwise appropriated, for the purpose of refunding to Mrs. Bob Freeman the amount

The written report of the City Manager on the advisability of opening West 32nd Street between Grandview and San Gabriel Streets, showing the cost of same to be prohibitive, was received and filed.

The application of Humberto Rivera, 1320 Inks Avenue, for license to operate as a taxicab a Chevrolet Sedan, 1934 Model, Engine No. 4301897, State Highway License No. 131-680, was read. Councilman Alford moved that the rule requiring that applications remain on file five days prior to being acted upon be waived and the application be granted. The motion was adopted by the following vote: Ayes, Councilmen Alford, Gillis, Mayor Pro tem Wolf, 3; nays, none; Councilman Bartholomew and Mayor Miller absent, 2.

W. D. Noton submitted to the Council a complaint that local butchers were being discriminated against by allowing out-of-town butchers to sell meat which had not had antemortem inspection.
