That the item, as contained in the budget of the Water, Light and Power Department for the year 1923, "Salary of Cashier at \$170,00 per month, \$2,040,00", be and the same is hereby amended so as to hereafter read as follows: "Salary · of Cashier at \$170.00 per month from January 1st to May 1st, and \$200.00 per month from May 1st to December 31st. 1923, \$2,280.00".
