Colorado Street at right angles 37.5 feet and easterly to a point and the present building line on the Southeast corner of Eighth and Colorado Street intersection.

THIRD: Thence measure from the above established center line of Colorado Street at right angles and Easterly 35.2 feet to a point and the present building line on the Northeast corner of Seventh and Colorado Street intersection.

Thus establishing a straight line between the present buildings on the East side of Colorado Street between Seventh and Eighth Streets, and between said two points for the East line of Colorado Street.

The above resolution was adopted by the following vote: Ayes, Mayor Yett, Councilmen Avery, Haynes, Nolen, and Searight, 5; nayes, none.

The report of the Safety Committee upon the application of G. Flury to hang an electric sign at T. H. Williams Store was read and Councilman Avery moved that same be adopted as recommended by the Committee.
