Austin, Texas, January 8, 1925.

The Council was called to order by the Mayor. Roll call showed the following members present: Mayor Yett, Councilmen Avery, Haynes, Nolen and Searight, 5; absent, none.

Councilman Haynes moved that the reading of the Minutes be suspended and the Council recess until ten o'clock A. M., January 10th, 1925. Motion prevailed by the following vote: Ayes, Mayor Yett, Councilmen Avery, Haynes, Nolen and Searight, 5; nays, none.

The Council then recessed.

SPECIAL MEETING OF THE CITY COUNCIL:

Austin, Texas, January 10, 1925.

The Council was called to order by the Mayor. Roll call showed the following members present: Mayor Yett, Councilmen Avery, Haynes, Nolen and Searight, 5; absent, none.

The Minutes of the last meeting were read and Councilman Avery moved that same be adopted. Motion prevailed by the following vote: Ayes, Mayor Yett, Councilmen Avery, Haynes, Nolen and Searight, 5; nays, none.

The communication of R. Barrow with reference to excess footage in Leon and West 24th Streets was read and Councilman Haynes moved that the communication be referred to the Street Commissioner and City Engineer for report back to the Council. Motion prevailed by the following vote: Ayes, Mayor Yett, Councilmen Avery, Haynes, Nolen and Searight, 5; nays, none.

Councilman Haynes introduced the following resolution:

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

That the sum of Eighteen Thousand, Three Hundred, Eighty-nine Dollars and Sixteen Cents (\$18,389.16) be and the same is hereby transferred from the Earnings Fund of the Water, Light and Power Department to the General Street Fund of the City of Austin; said amount being the amount of overdraft of the General Street Fund on December 31, 1923.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

That the sum of One Hundred, Forty-four Thousand, Six Hundred, Thirty-nine Dollars (\$144,639.00) be and the same is hereby transferred from the Earnings Fund of the Water, Light and Power Department to the General Fund of the City of Austin, said amount being the amount of overdraft of the General Fund on December 31, 1923.

A. C. Baldwin and Prof. J. C. Bryant appeared before the Council and protested against the above transfers. After hearing said protest, Councilman Haynes moved the adoption of the resolution as read. Motion prevailed by the following vote: Ayes, Mayor Yett, Councilmen Avery, Haynes, Nolen and Searight, 5; naves, none.
