Austin, Texas, August 8, 1925.

McFadden and other merchants on Guadalupe Street between 23rd and 24th Streets was read and Councilman Avery moved that same be referred to the City Engineer for his report back to the Council. The application of H. F. Ritter to install a gasoline pump over gutter at 23rd Street and East Avenue was refused by the following vote: Ayes, Mayor Yett, Councilmen Avery, Haynes, and Nolen, 4; naves, none, Councilman Searight absent.

The report of the Safety Committee upon the application of Chris B.
