all, or substantially all, of the Company's electric properties and business; and that the Company, or such assignee, would not be responsible for the performance of the obligations with respect to the maintenance and operation of said Dam or Hydro Station.

11. That an Ordinance, in such form as the Company and its attorneys shall approve, shall be passed, setting forth, in appropriate language, the various terms and conditions above mentioned, and such additional terms and conditions as the parties may deem proper or necessary for their mutual protection. .

The application of G. Flury to hang an electric sign at T. H. Williams Store at 5th and Congress Avenue was read and referred to the Safety Committee for report back to the Council.

Communication of Geo. S. Dowell, Attorney for L. Soderburg, was read and Councilmen Haynes moved that same be referred to Councilmen Avery. Motion prevailed by the following vote: Ayes, Mayor Yett, Councilmen Avery, Haynes, Nolen, and Searight, 5; nayes, none.

The application of the English Sign Company to hang an electric sign at 2218 Guadalupe Street, together with the Safety Committee's report upon same, was read and granted by the following vote: Ayes, Mayor Yett, Councilmen Avery, Haynes, Nolen, and Searight, 5; nayes, none.

The Committee's report upon the application of H. H. Severn for permission to install a gasoline pump at 19th and Chicon Streets, was read and Councilman Haynes moved that same be granted. Motion prevailed by the following vote:
Ayes, Mayor Yett, Councilmen Avery, Haynes, Nolen, and Searight, 5; nayes, none.

The application of the English Sign Company to erect an electric sign at W. F. Crawford's store, 521 Congress Avenue, together with the Safety Committee's report upon same, was read and Councilman Haynes moved that same be granted. Motion prevailed by the following vote: Ayes, Mayor Yett, Councilman Avery, Haynes, Nolen, and Searight, 5; nayes, none.

The communication of Anna I. Sandbo, Attorney for Mrs. E. J. White, was read and ordered filed.

Mayor Yett introduced the following resolution:

WHEREAS, on November 15, 1886, the City Council of the City of Austin, Travis County, Texas, passed that certain City Ordinance in words and figures substantially as follows, to-wit:

"AN ORDINANCE LOCATING RIVER STREET:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

'Sec. 1. That River Street shall be and is hereby located as follows, to-wit: Beginning at a point on the West line of East Avenue seventy feet south of Lot No. One in Block No. One of subdivision of Outlots Nos. 72 and 73, in Division "E", Driskill and Rainey's Addition to the City of Austin; Thence West at right angles to East Avenue to the Colorado River; Thence down said river sixty feet to a stake; Thence Eastwardly parallel

with the first line to East Avenue; Thence Northwardly with the West line of East Avenue to the place of beginning.

'Sec. 2. That River Street as shown on the maps or plat of said Driskill and Rainey Addition to the City of Austin be and the same is hereby abandoned and discontinued.

'Sec. 3. This ordinance shall take effect and be in force from and after its passage.

'Passed: Nov. 15th, 1886 Approved: Nov. 19, 1886 Signed: J. W. Robertson, Mayor. Attest: Milton Morris, City Clerk*

and

WHEREAS, the seventy feet just South of and adjoining said Lot No. 1, in Block No. 1, of said Driskill and Rainey Subdivision was conveyed by Frank Rainey to Mrs. Annie M. Soudder by deed dated July 9, 1894, and recorded in Book 126, page 304, of the Travis County Deed Records, and on January 21, 1903, conveyed by M. R. Soudder to Mrs. E. J. Showalter (now Mrs. E. J. White) wherein said 70 feet is described as Lot *O*, by deed recorded in Book 183, page 196, Travis County Deed Records, which said deeds and the said records thereof are hereby expressly referred to and made a part hereof for all proper purposes; and

WHEREAS, said Mrs. E. J. White has requested of the City of Austin that it convey to her said 70-foot strip of land adjoining said Lot No. 1, in Block No. 1 of said Driskill and Rainey Subdivision in order to clear her title to said property.

Now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

That the Mayor be and he is hereby authorized and instructed to execute for the City of Austin a quit claim deed to said Mrs. E. J. White of said lot hereinabove mentioned.

The above resolution was adopted by the following vote: Ayes, Mayor Yett, Councilmen Avery, Haynes, Nolen, and Searight, 5; nayes, none.

The Council then recessed.

SPECIAL MEETING OF THE CITY COUNCIL OF THE CITY OF AUSTIN:

Austin, Texas, May 3, 1926.

The Council met, the following members present: Mayor Yett, Councilmen Avery, Haynes, Nolen, and Searight, 5; absent, none.

Councilman Avery moved that Dean F. C. Bolton be appointed as advice expert in connection with the Texas Power & Light Company's proposition to furnish power to the City of Austin, said employment to be evidenced by contract to be drawn by the City Attorney as proposed. Ayes, Mayor Yett, Councilmen Avery and Haynes, 3; nayes, Councilmen Nolen and Searight, 2.

Mayor Yett moved that Councilman Avery be authorized to negotiate with H. C. Weaver for assistant to F. C. Bolton, and report back to the Council. Motion prevailed by the following vote: Ayes, Mayor Yett, Councilman Avery, Haynes, and Nolen, 4; nayes, Councilman Searight.

The Council then adjourned.
