Austin, Texas, June 26, 1930.

A committee of citizens appeared to protest against the granting of a permit to R. A. Spears for the erection of a gasoline filling station at the southeast corner of Twenty-ninth and Ric Grande Streets. Councilman Pannell moved that action upon the matter be postponed until the Zoning Commission has had its hearing in this particular area. Motion was seconded by Councilman Mueller, and same prevailed by the following vote: Ayes, Mayor McFadden, Councilmen Mueller, Pannell, and Steck, 4; nays, none; Councilman Reed absent.

This being the day set for the hearing of owners of abutting property and others interested with reference to street improvements to be constructed in the certain Units or Districts of Improvement, as follows:

RED RIVER STREET from the North line of Nineteenth Street to the North line of Twenty-Fourth Street, known and designated as Unit or District No. 43;

RED RIVER STREET from the North line of Twenty-fourth Street to the North line of Thirty-second Street, known and designated as Unit or District No. 44;

all as awarded to L. E. Whitham & Co.

the Mayor thereupon stated that all persons desiring to protest against the levying of assessments against abutting property on the above mentioned street and within the limits above stated, or who desired to be heard with reserence to the improvements proposed to be assessed against said property and the owners thereof, the lien and liability thereof, the special benefits to the property and the owners thereof, or any

other matters or things authorized by the provisions of Article XXIV of the Charter of the City of Austin to be urged and considered at this hearing would now be heard from, and thereupon the following property owners were heard:

The above resolution was adopted by the following vote: Ayes, Mayor McFadden, Councilmen Mueller, Pannell, and Steck, 4; nays, none; Councilman Reed absent.

The Mayor laid before the Council the following resolution:

WHEREAS, the Park Board has advised the City Council of the City of Austin that in order to complete the playground on the east bank of Shoal Creek immediately west of West Avenue and south of West 10th Street, it will be necessary to purchase .647 of an acre of land located immediately south of the property recently purchased by the City from C. M. Bartholomew, belonging to Lon A. Smith; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

That the City Manager be authorized to purchase the above described land from the said Lon A. Smith at a price not to exceed \$1,000.00, and that the sum of \$1,000.00 be appropriated out of the Parks and Playgrounds Bond Fund for said purpose.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

THAT Texas Public Service Company be and the same is hereby permitted to lay and construct its gas mains in and upon the following streets:

(1) A 4 inch low pressure gas main in LeGrande Avenue beginning at a point 29 feet north of and 90 feet east of the intersection of the east line produced of that part of Newning Avenue that is north of LeGrande Avenue and the south line of said LeGrande Avenue;

Thence in a westerly direction 29 feet north of and parallel to the south line of LeGrande Avenue a distance of approximately 1/2 block to a point where said main will intersect with a line 20 feet south of the north line of that portion of LeGrande Avenue that is west of Hillside Drive;

Thence in a westerly direction 20 feet south of and parallel to the north line of LeGrande Avenue a distance of approximately one block to the west line of Melissa Lane. Said gas main described above shall have a cover of not less than 2 feet.

(2) A 4 inch low pressure gas main in Chicon Street beginning at a point 27 feet south of and 21 feet west of the intersection of the north line of East Nineteenth Street and the east line of Chicon Street;

Thence in a southerly direction 21 feet west of and parallel to the east line of Chicon Street a distance of approximately two blocks to the north line of East Seventeenth Street. Said gas main described above shall have a cover of not less than 22 feet.

(3) A 4 inch low pressure gas main in Rainey Street beginning at the end of an existing gas main, which end is 25 feet north of and 17 feet east of the intersection of the north line of River Street and the west line of Rainey Street;

Thence in a southerly direction 17 feet east of and parallel to the west line of Rainey Street a distance of approximately 60 feet to a point 32 feet south of the north line of River Street. Said gas main shall have a cover of not less than 3 feet.

(4) A 4 inch low pressure was main in River Street beginning at a point 17 feet east of and 32 feet south of the intersection of the north line of River Street and the west line of Rainey Street;

Thence in a westerly direction 32 feet south of and parallel to the north line of River Street a distance of approximately one-half block to a point 26 feet east of the west line of Bierce Street. Said was main described above shall have a cover of not less than 32 feet.

(5) A 4 inch low pressure gas main in Bierce Street, beginning at a point 32 feet south of and 26 feet east of the intersection of the north line of River Street and the west line produced of Bierce Street;

Thence in a southerly direction 26 feet east of and parallel to the west line of Bierce Street a distance of approximately one block to the north line of Cummings Street. Said gas main described above shall have a cover of not less than 4 feet.

Austin does not guarantee that the space assigned above is clear from other underground utilities, but is based upon the best records we have at hand, and that the minimum depth stated does not have any reference to the fact that greater depths may be required at special points. When the Texas Public Service Company requires definite information upon the ground as to elevations or working points from which to base the location of their assignments they shall apply to the City Engineering Department not less than three (3) days before such information is required. The Texas Public Service Company is further put upon notice that they will be required to bear the expense of repairs or replacement of any underground utility damaged during the construction of lines named in this resolution.

That the work and laying of said gas mains, including the excavation in the streets and the restoration and maintenance of said streets after said mains have been laid, shall be under the supervision and direction of the City Manager, and under all the pertinent terms and conditions of the certain franchise granted to said Company by the City of Austin.

EMFIELD ROAD from the East lines of Blanco Street and Windsor Road to the West line of West Lynn Street, known and designated as Unit or District No. 466; and that the same be improved with the same kind of improvements provided for as to said original Unit or District No. 46, but making changes in the plans with reference to the widths to which such improvements should be made so as to provide that each of said units or districts shall be improved between existing curbs so far as said curbs

are found sufficient by the Consulting Enrineer of the City. RESOLUTION APPROVING AND ADOPTING ESTIMATE OF THE COST OF IMPROVE-MENTS AND OF AMOUNTS TO BE ASSESSED FOR IMPROVEMENTS ON A PORTION OF NUECES STREET AND PORTIONS OF SUNDRY OTHER STREETS IN THE CITY OF AUSTIN, TEXAS, FIXING TIME AND PLACE FOR HEARING TO THE OWNERS OF ABUTTING PROPERTY, AND DIRECTING THE CITY MANAGER TO GIVE NOTICE.

WHEREAS, the City Council of the City of Austin has heretofore ordered that the hereinbelow mentioned portions of highways be improved by raising, grading and filling and installing concrete curbs and gutters, and by paving with 2 inch Warrenite Bitulithic Wearing Surface on a 6 inch concrete base, with necessary appurtenances, and contract therefor has been made and entered into with Southwest Bitulithic Company; and

WHEREAS, the City Council has caused the City Engineer to prepare and file estimates of the cost of such improvements and estimate of the amounts per front foot proposed to be assessed against abutting property and the owners thereof, and such estimates have been examined.

Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

I.

That such estimates be and they are adopted and approved.

II.

That it is hereby found and determined that the cost of improvements on each such portion of highway, with the amount or amounts per front foot proposed to be assessed for such improvements against the abutting property and owners thereof, on each such portion of street or highway are as follows, to-wit:

NUECES STREET from the north property line of West Sixth Street to the south property line of West Nineteenth Street, known and designated as Unit or District No. 54, estimated cost of improvements i \$57,847.89. Estimated amount per front foot to be assessed for curb and gutter is \$.70. Estimated amount per front foot to be assessed against abutting property and its owners for improvements exclusive of curb and gutter is \$4.416. Total estimated amount per front foot to be assessed against abutting property and its owners is \$5.116.

SOUTH CONGRESS AVENUE from the north property line of Nellie Street to Bouldin Creek Station 31-51.1, known and designated as Unit or District No. 57; estimated cost of improvements is \$22,429.09. Estimated amount per front foot to be assessed for curb and gutter is \$.70. Estimated amount per front foot to be assessed against abutting property and its owners for improvements exclusive of curb and gutter is \$6.456. Total estimated amount per front foot to be assessed against abutting property and its owners is \$7.156.

III.

That a hearing be given and held by and before the City Council of the City of Austin, Texas, to all owning or claiming any property abutting upon any of said portions of streets and highways, as well as all owning or claiming any interest in any such property. Such hearing shall be given and held on the 10th day of July, 1930, at 10:30 o'clock A. M., in the regular Council meeting room in the City Hall in the City of Austin, Texas, and the City Manager is hereby directed to give notice of the time

and place of such hearing, and of other matters and facts, in accordance with the terms and provisions of Article XXIV of the Charter of the City of Austin, which Article was added by amendment adopted at an election held on November 24th, 1928. Such notice shall be by advertisement inserted at least three times in a newspaper published in the City of Austin, Texas, the first publication to be made at least ten days before the date of said hearing. Said notice shall comply with and be in accordance with the terms and provisions of said Article XXIV.

The above resolution was adopted by the following vote: Ayes, Mayor McFadden, Councilmen Mueller, Pannell, and Steck, 4; nays, none; Councilman Reed absent.

The Engineer's Roll of H. R. F. Helland, Consulting Engineer, showing the estimated cost of improvements on East Avenue from the south line of East Sixteenth Street to the south property line of East Nineteenth Street, known and designated as Unit or District No. 50; East Avenue from the south property line of East Nineteenth Street to the north property line of East 23rd Street or Manor Road, known and designated as Unit or District No. 51; East Sixteenth Street from the west property line of Sabine Street to the east property line of Navasoth Street, known and designated as Unit or District No. 52; West Sixth Street from the west property line of West Lynn Street to the west property line of International Great Northern Railway, known and designated as Unit or District No. 55, was read and ordered filed.

The Mayor then laid before the Council the following resolution:

That it is hereby found and determined that the cost of improvements on each such portion of highway, with the amount or amounts per front foot proposed to be assessed for such improvements against the abutting property and owners thereof, on each such portion of street or highway are as follows, to-wit:

EAST AVENUE from the south property line of East Sixteenth Street to the south property line of East Nineteenth Street, known and designated as Unit or District No.50; estimated cost of improvements is \$24,920.79. Estimated amount per front foot to be assessed for curb and gutter is \$.70. Estimated amount per front foot to be assessed against abutting property and its owners for improvements exclusive of curb and gutter is \$6.778. Total estimated amount per front foot to be assessed against abutting property and its owners is \$7.478.

EAST AVENUE from the south property line of East Nineteenth Street to the north property line of East 23rd Street or Manor Road, known and designated as Unit or District No. 51. Estimated amount per front foot to be assessed for curb and gutter is \$.70. Estimated amount per front foot to be assessed against abutting property and its

owners for improvements exclusive of curb and gutter is \$4.216. Total estimated amount per front foot to be assessed against abutting property and its owners is \$4.916. Estimated cost of improvements is \$25,338.71.

EAST SIXTEENTH STREET from the west property line of Sabine Street to the east property line of Ravasota Street, known and designated as Unit or District No. 52. Estimated cost of improvements is \$9,895.28. Estimated amount per front foot to be assessed for curb and gutter is \$.70. Estimated amount per front foot to be assessed against abutting property and its owners for improvements exclusive of curb and gutter is \$3.071. Total estimated amount per front foot to be assessed against abutting property and its owners is \$3.771.

WEST SIXTH STREET from the west property line of West Lynn Street to the west property line of International Great Northern Railway, known and designated as Unit or District No. 58. Estimated cost of improvements is \$15,038.69. Estimated amount per front foot to be assessed for curb and gutter is \$.70. Estimated amount per front foot to be assessed against abutting property and its owners for improvements exclusive of curb and gutter is \$3.368. Total estimated amount per front foot to be assessed against abutting property and its owners is \$4.068.

III.

That a hearing be given and held by and before the City Council of the City of Austin, Texas, to all owning and claiming any property abutting upon any of said portions of streets and highways, as well as all owning and claiming any interest in any such property. Such hearing shall be given and held on the 10th day of July, 1930, at 10:30 o'clock A. M., in the regular Council meeting room in the City Hall in the City of Austin, Texas, and the City Manager is hereby directed to give notice of the time and place of such hearing, and of other matters and facts, in accordance with the terms and provisions of Article XXIV of the Charter of the City of Austin, which Article was added by amendment adopted at an election held on November 24th, 1928. Such notice shall be by advertisement inserted at least three times in a newspaper published in the City of Austin, Texas, the first publication to be made at least ten days before the date of said hearing. Said notice shall comply with and be in accordance with the terms and provisions of said Article XXIV.

Ayes, Mayor McFadden, Councilmen Mueller, Pannell, and Steck, 4; nays, none; Councilman Reed absent.
