The Council was called to order by the Mayor : Roll called:

On motion the readings of the minutes was postponed until the next regular meeting of the Council :

Councilman Powell offered the following resolution:

Resolved by the City Council of the City of Austin, Texas :

That the Supt of Streets and Public Improvements of the City of Austin, Texas , be and he is hereby authorized and instructed to order ,by the proper legal procedure ,the paving of Brasos street in this City from the alley between 10th & 11th streets to the north side of 11th street in this City.

The resolution was adopted by the following vote :

Councilman Powell offered the following resolution :

Resolved by the City Council of the City of Austin, Texas :

Be it further resolved by the City Council of the City of Austin, Texas :

That the Supt of streets and public Improvements be and he is hereby instructed to invite bids for the construction of any or all of said bridges, which bids are to be received by the City Council on or before 10 O'clock A M, of Monday February 7th 1916, A certified check of ~~1/2~~ 5% of the amount of bid must accompany each bid.

Councilman Powell offered the following resolution :

Be it resolved by the City Council of the City of Austin, Texas :

That the sum of eighty one & 13/100 (\$81.13) dollars be and the same is hereby appropriated out of the General Street fund to pay for gravel hauled from Landa pit to repair south Congress Avenue.

January 18th. All present.

Councilman Powell presented Bids for State Street Bridge, across Shoal creek, which were opened, read and compared.

Councilman Powell moved to accept the bid of Mr A A Mumdt, he being the lowest and best bidder, which motion prevailed by the following vote:
