Reselved further:

That the work under this resolution aut orized to be installed and maintained must be installed and maintained , where not otherwise assigned, under the immediate supervision of the City Engineer of Austin, Texas, who is hereby authorized to prescribe necessary specifications for the work herein authorized to be done.

Resolved Further :

That this permit is granted only for the installation of a gasoline tank and pump and does not include the installation or construction of a storage box for hose underneath the sidewalk, and

Resolved further and finally:

That this permit is granted and must be accepted as revocable at any time in the pleasure of the City Council.
