#### Petitions, memorials, etc:

The Mayor laid before the Council the petitions of Fred S Boutelle and R M Thomson, asking to have pound fees refunded, each of which were approved by him. On motion the petitions were granted.

By Alderman Petri Petition of H Creutzfeldt asking for the same privileges as that granted to Nalle & Co, in regard unloading cars at the switch at the Alliance Cotton yard: On motion the petition was granted, subject to the same conditions as that granted to Nalle & Co.

Hon Mayor members of City Council.

*Paving, or Retaining Wall etc*

As instructed by you, your Paving Committee advertised for new bids for retaining wall and extension of storm sewer at foot of Congress Avenue. Two bids were received. One from C Q Horton, agreeing to do the work as specified for \$8980.00; one from Knape & Bro agreeing to do the work for \$10,450.00; both bids received with certified check attached. We returned Knape & Bro their bid with check, and herewith turn over to the City Clerk, C Q Horton's bid with check attached, and leave the matter of making contracts for the work as above specified to your Honorable body. urging you to make the contract at the earliest possible date, so that this necessary retaining wall and extension of storm sewer can be built at once, and not delay paving now starting from 3rd street to the new bridge.

A sub-committee of Paving, or Paving Committee, consisting of Harrell, Scott & Eiler were appointed to see Guy S Boyce and make a contract with him to superintend construction of retaining wall, extension of storm sewer and paving of Congress Avenue and other streets until all work contracted for, is finished at 2 1/2 % of amount of said contract. This contract was closed with Mr Boyce, and we request Council to ratify same.

*Report of Com on Streets*

Gentlemen: Your Committee on streets as instructed by the City Council advertised for bids to grade 27th street where it intersects the Speedway, west from the Speedway 150 feet. Bids were received from Mr Canion for \$725.00, and from Mr Rutledge for \$875.00. Your Committee on streets recommend the bid of Mr Canion be accepted, and that the Mayor be authorized to enter into contract with Mr Canion in accordance with his bid.

Unfinished business

*Water Light Commission building the wall*

The Mayor laid before the Council a resolution authorizing the Water & Light Commission to erect a building, on part of Block no 98, in the City of Austin. Alderman Haynes moved to amend the resolution by adding "providing, that the Water and Light Commission have no control or use of the City hall lot west of the west wall of the building proposed." On motion the whole matter was referred to the Fire and City hall Committees.

The Mayor laid before the Council the report of the Street and Sanitary Committees recommending the purchase of lots for stables for City teams, Alderman Wilhelm submitted a proposition from D W Weaver to sell a piece of property on east 4th street

Alderman Wilhelm offered the following resolution

Whereas it is deemed necessary by the City Council of the City of Austin, that the City of Austin purchase property within the corporate limits of the City of Austin sufficient in size to accommodate the wagons and teams belonging to the City of Austin, and sufficient in size to store certain poles and materials belonging to the City of Austin;

Therefore, be it resolved by the City Council of the City of Austin, that the City of Austin advertise for bids for property suitably located and of sufficient quantity to accommodate said teams, wagons, telegraph poles and materials used by the City of Austin and the Water and Light Department of the City of Austin; and

Be it further resolved that parties having property which is deemed by them desirable for the purpose here set out shall submit in writing to a Committee appointed for that purpose the price of said property, together with an accurate description thereof; and

Be it further resolved that no property shall be considered which does not contain as much as one-half block, and which is more than 12 blocks from the City Hall of the City of Austin; and

Be it further resolved that property lying adjacent to and situated on one of the railroad tracks entering the City of Austin be given a preference

Alderman Crooker moved that the matter lie on the table subject to call, which motion was lost by the following vote;

#### New business

The Mayor laid before the Council telegrams from the Consolidated Construction Company of New York, asking an extension of time in which to make deposit of money on contract to rebuild the dam. On motion the telegrams were referred to the Finance and Ordinance Committees;

The Mayor laid before the Council a communication from J M Fox, tendering his resignation as a policeman. On motion the resignation was accepted.

On motion of Alderman Smith the Marshal was directed to submit a name of a successor to Mr Fox. The Marshal submitted the name of Ed Radcliff.

Aldermen Smith & Miller were appointed as tellers. The tellers reported that there were cast 6 votes for confirmation. The Mayor declared that Mr Radcliff having received a majority of the votes of the Council was confirmed as a Policeman.

On motion of Alderman Cuneo City Attorney W D Hart was granted a leave of absence from December 20th 1907 until January 1st 1908.

Alderman Redd offered the following resolution;

Be it resolved by the City Council of the City of Austin, that the following rule be and the same is hereby adopted by the City Council as a rule of procedure to govern the members thereof, viz:

That in all debates on any question submitted to a vote of said Council, no member of the Council shall be allowed but one hearing on the one question, and that such hearing shall be limited two minutes duration.

That it shall be the duty of the Mayor or Chairman of the Council to rigidly enforce this rule, and no exception shall be made to this rule except by unanimous consent of the whole Council; On motion the resolution was referred to a Committee consisting of Aldermen Armstrong, Meredith and Moreland.

By Alderman Moreland an ordinance providing for the publishing of all notices of sale of stock impounded by the City of Austin. The ordinance was read the first time and on motion the rule was suspended and the ordinance placed on its second reading by the following vote:

Be it resolved by the City Council of the City of Austin that the tax rolls of the City of Austin for the year 1907 as prepared by the City Assessor and Collector be and they are hereby approved in all things and the said rolls are hereby accepted as the tax rolls for said City for the year 1907

By Alderman Haynes an ordinance appropriating the sum of \$95.70 for the purpose of paying certain approved accounts. The ordinance was read the first time, and passed under suspension of the rules by the following vote:
