

Regular meeting of the City Council, Austin, Texas, December 15th 1907

Hon. F. M. Maddox, Mayor, presiding;

Roll called:

On motion the minutes were approved as recorded by the Clerk without reading

By Alderman Crocker, petition of J. L. Vredenberg, asking correction of assessment, Read and on motion referred to the committee on Claims and accounts

By Alderman Crocker, petition of Citizens and property owners on Wichita Street asking for street work on said street, read and on motion referred to the street Committee and City Engineer.

The Mayor laid before the Council a petition from W. J. Johnson, asking to have certain pound fees refunded, read and on motion referred to the Committee on Claims and Accounts.

The Mayor laid before the Council an invitation from East Austin Hose Company No. 4 inviting the Mayor, Board of Aldermen, City Officials and their families to attend their annual New Year's ball to be given at their Hall on January 1st 1908. On motion the invitation was accepted.

Reports of City Officers,

The Mayor laid before the Council the reports of the City Treasurer and Marshal for the month of November 1907, which were on motion referred to their appropriate Committees, without reading.

Reports of Standing Committees,

Alderman Scott for the street Committee to whom was referred a resolution requesting Rail Road Companies to put in gates at the intersection of Congress Avenue and third street, presented a report, stating that in the opinion of the street Committee, it is not advisable at present to put in said gates. Mr Goeth stated that on Congress Avenue below 3rd street the curb line was out in the street and that property owners objected to moving the curb back, but had agreed that if the City would bear the expense of moving the curbing they would not object to its being moved, and the Committee would recommend that the City have same moved , at the expense of the City

The Paving Committee recommended the employment of an Assistant to the City Engineer for a period of six months. On motion the recommendation of the Committee was adopted .

Alderman Armstrong for the special Committee on Rules to whom was referred a resolution to amend the rules of the Council presented the following report;

To the Hon F M Maddox, Mayor, and City Council of Austin ;

Gentlemen : we, your Committee to whom was referred a resolution by Alderman

Redd limiting the time allowed for debates on questions submitted to the Council, recommend the adoption of the following rule, as a substitute for Mr Redd's

resolution . That in all debates on questions submitted to the Council, each member thereof shall have the privilege of the floor for Ten minutes, if he so

before any member shall be allowed to speak the second time, Members wishing to speak the second time on a question shall be allowed five minutes in which to do so. Any member wishing to speak a third time must state the time wanted when asking for such permission and must have the consent of two-thirds of the members present before being allowed the privilege. When a question is debated on by sections these same rules shall apply, excepting the time allowed, which in this case shall be three minutes. It shall be the duty of the Presiding Officers to rigidly enforce this rule, and any rule or parts thereof previously adopted by the City Council conflicting with these rules shall be and is hereby repealed.
