We have carefully considered the matter of the partial acceptance of b the CityHall and would make the following suggestion, subject to your approval:

We would suggest that such contract as the City has with Messar Belger & Brymon be left in its present form, and that the City accept the building under the conce contract from Messars Belger & Brydson, except the stairway and stair vestibule, which is not yet complete with the City retain from the contract price the sum of \$ 1500,00, which said sum of \$ 1500,00 shall be paid to Messars Belger & Brydson upon the completion of the stairway and stair vestibule, according to the plans and specifications heretorore adopted and agreed upon covering that portion of the contract. We recommend that 45 days from this date, namely, Jan, 9, 1906, be given Messars Belger & Brydson in which to complete the stairway and stair vestibule, according to the plans and specifications heretofore adopted covering the stairs and stair vestibule, and that, in the event such stairway and stair vestibule be not completed according to the plans and specifications
