

Regular meeting of the City Council : Austin, Texas, Sept 5th 1917:

The Council was called to order by the Mayor: Roll called:

Present Mayor Wooldridge, Councilmen Anthony, Bartholomew, Haynes & Powell 5

The minutes of the last regular and subsequent recessed meetings were read and adopted:

Reports of City Officers:

The Mayor laid before the Council the reports of the Assessor & Collector, the Sexton, the Public Weigher, the Inspector of Weights and Measures, the City Engineer & the Plumbing Inspector, which were read and filed:
