That the sum of forty five (\$ 45.00) be and the same is hereby appropriated out of the general contingent fund of the City of Austin, Texas, to assist in paying the rental for the Boy Scouts room at the old armory at the corner of West 10th street and Congress Avenue in this City ,formerly occupied by Companies "E" and "F" of the Texas National Guard.

By Mayor Wooldridge ,An ordinance to amend Section 10 of an ordinance entitled "An ordinance regulating the business of Junk dealers and declaring penalties for the violation thereof," passed and approved November 9th 1917.

The ordinance was read the first time and passed under suspension of the rules by the following vote:

Mayor Wooldridge offered the following resolution :

Whereas, at a meeting of the City Council of the City of Austin, Texas, held on the 27th day of December 1917, the same being the regular meeting of said Council, came on to be considered the returns of an election held on the 20th day of December, 1917, to determine whether or not the City Council of the City of Austin be authorized to issue bonds of said City and to annually levy a tax sufficient to pay the interest on said bonds and to create a sinking fund of at least two(2) per cent of the principal of said bonds and sufficient to redeem said bonds at maturity, as follows:

1. In the sum of fifty thousand (\$ 50,000.00) dollars for the purpose of taking up cancelling and in lieu of a like amount of legally issued outstanding School warrants of the City of Austin, being warrants numbered 10329 to 11078, both inclusive, except warrant No 10439 and 10706, issued to various parties in various sums, said bonds to be payable as follows: One thousand (\$ 1,000.00) dollars each year for ten(10) years after their date, and two thousand dollars(\$2,000.00) each year for twenty (20) years after the expiration of said ten(10) years, said bonds to bear interest at the rate of five per cent (5%) per annum, payable semi-annually.

2. In the sum of one hundred thousand (\$ 100,000.00) dollars for the purpose of constructing and installing a sewer disposal Plant for the City of Austin, payable as follows: Twenty five (\$ 2,500.00) each year for forty (40) years after their date, said bonds to bear interest at the rate of five per cent (5%) per annum from their date, payable semi-annually.

3. In the sum of twenty five thousand (\$25,000.00) dollars for the purpose of remodeling and improving the old City Hospital building of the City of Austin, said bonds to be payable as follows: One thousand (\$1,000.00) dollars each year for twenty five years, said bonds to bear interest at the rate of five per (5%) cent per annum from their date, payable semi-annually; and

Whereas, it appearing that said election was on said date in all respects lawfully and properly held, and that the returns of said election were duly and legally made and that there were cast at said election the following votes:

1. For the issuance of School bonds	1112 votes
Against the issue of School bonds	271 votes
2. For the issuance of Sewer disposal bonds	667 Votes
Against the issuance of Sewer disposal plant bonds	665 votes
3. For the issuance of Hospital bonds	871 votes
Against the issuance of Hospital bonds	477 votes

And where as, it appearing that said School bonds received more than two-thirds of the votes cast at said election, and that said Sewer disposal plant bonds and said City Hospital bonds each failed to receive two-third of the votes cast at said election; therefore,

Be it resolved by the City Council of the City of Austin :

Section 1. That it is hereby ordered and declared that the proposition to issue School bonds and to levy taxes therefor was sustained by a two-third majority of the qualified property tax payers voting at said election and that the City Council of the said City is authorized to issue said School bonds and to levy and have assessed and collected said taxes.

(2) That said sewage disposal plant bonds and said Hospital bonds having failed to receive two-thirds of the votes cast at said election, the City Council is not authorized to issue said bonds and levy taxes therefor.

3. It is directed that the City Clerk be and he is hereby instructed to enter these proceedings in the minutes of the City Council.
