Whereas, it is impossible to provide the necessary buildings for the safe and comformable accommodation of the rapidly increasing scholastic population of the City at the present rate of taxation for school purposes, and continue the schols the full term of nine months, and,

Whereas, the Board of Trustees are not willing to assume the responsibility of curtailing the school termfrom nine months to seven months in the year, unless it be expressed will of the citizenship of the City, therefore,

Be it resolved By the Board of Trustees, that the Honorable Mayor and City Council of the City of Austin, be requested to call an election for the issuance of \$50,000.00 worth of C:School Bonds for building and repair purposes.

Be it further resolved , that in view of the financial condition of the schools of this City, and the becessity of cutailing the school term this year if more funds are not provided, that the Council be requested to call this election at the earliest practicable time.

A number of the members of the School Board were present and addressed the Council, on the resolution, but no definite action was taken by the Council. The Mayor nominated J K Richardson Esq as CAssistant City Attorney and asked his confirmation.
