Gentlemen:

Dr. Z. T. Scott and his architect, Mr. George Louis Walling, have personally requested me to have a building line established for the corner of 7th and Brazos Streets. About 14 years ago the City of Austin established center lines for both 7th and Brazos Streets. I would like to see all established center lines used as the basis for all new buildings, but in previous instances, the present Council has adopted the policy of making practical adjustments respecting the present use of the City streets as evidenced by existing buildings. In accordance with this policy, I recommend that the building line for the west side of Brazos Street shall be established as 40 feet distant from and parallel to the established line of Brazos Street, and that the building line be established on the north side of 7th Street, the same to be an extension of the building line as now evidenced by the Stephen F. Austin Hotel.

For the purpose of explaining the existing conditions, Dr. Scott has had a private surveyor prepare maps which are presented for your consideration at this time. I have also prepared a map showing the line which I recommend as an extension of the Stephen F. Austin Hotel building line, together with comparisons of the amount of land which the property owners will gain and the amount of the street which the City will lose.

In the event the property owner should attempt to contend that he has established limitation rights in this street, I recommend that this matter be referred to the City Attorney, granting him ample time to make a study of the legal phases of the conditions as presented.
